FRANK CHRISTOPIAN

Since 2011, Frank has been a fulltime college professor at Eastern Florida State College (EFSC). Currently, he is serving as the Business Department Chair at the EFSC Melbourne Campus. Since 2009, he has taught graduate-level courses at the Florida Institute of Technology (FIT). He has extensive experience with academic program and coursework development, credentialing requirements, and academic technology. He has known Dr. Katherine Cobb (HTEA – President) for many years while she was a Provost at EFSC. He is particularly interested in working with HTEA since education is his professional career. Previously, he spent twenty-two years in the aerospace and defense industry at Northrop Grumman Corporation in various facilities and sites from California to Florida. During his years in aerospace, he was able to complete two master's degrees and a doctorate, which is essential for him as a college professor. Many years ago, Frank started attending the Episcopal Church as a college student. He was most impressed by the liturgy, the Eucharistic Prayers, and the myriad rites, ceremonies, and prayers of the Book of Common Prayer. He never considered going to church anywhere else other than the Episcopal Church since his late teens. He has been a member of Holy Trinity Episcopal Church since 2007 and attends the 9:00 am service. He serves every fourth Sunday as an usher.
