

Biography

He is nationally recognized for his work with affordable housing, mixed income communities and community revitalization. His work has received awards and acknowledgement for contributions to the community.

Mr. Hruby is active in community and professional affairs in Naples Florida, where he has resided for the past 26 years. He served on the board of directors of the Naples Zoo. He presently serves on the board of directors for AIA Florida Southwest and has served on the board of directors of AIA Florida.
