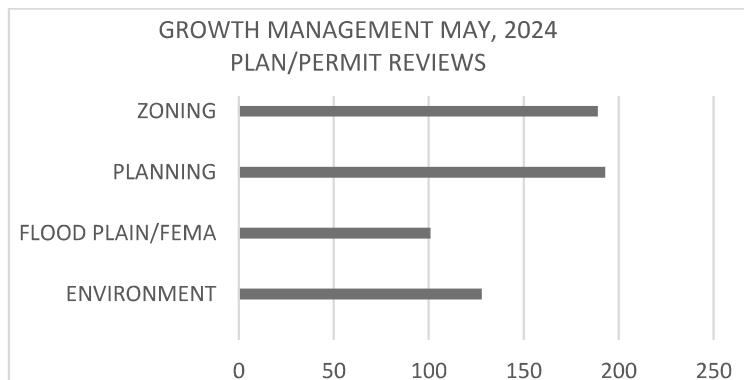

May was a busy month, primarily with plan and permit reviews, preparing for Planning Board, Beach and Coastal, City Council, and the Ad Hoc Redevelopment Committee meetings, responding to questions and inquiries from residents, developers, and elected officials, attending meetings over various topics and projects and processing Growth Management permits. So far, per Collier County's Sea Turtle Monitors, Marco Island has a reported 26 total nests thus far! With the increased outreach prior to nesting season, we hope to have reduced human interference and increased hatchling survival rates!
