Draft Plan Presented for Public Comment

### **Public Information Session and Comment Period**

The New York State Department of Environmental Conservation (DEC) is holding a public information session seeking public comment on a draft Great Divide Unit Management Plan (UMP).

The public is invited to the Horseheads Free Library, 405 S. Main St, Horseheads, NY 14845 beginning at 5:00 pm on July 16, 2025.

A short presentation on the draft plan will begin at 5:15 pm, followed by a question-and-answer period. The library is wheelchair accessible.

The Great Divide UMP includes the properties covered in the original Great Divide Unit (2006) plus the former Erwin Unit Management Plan (2008). It provides a long-term vision for the management of 7,308 acres of State Forests (SF) and Wildlife Management Areas (WMAs) located in Chemung, Steuben and Schuyler counties. The UMP establishes management goals and objectives, and addresses management activities on this Unit for the next ten years. Factors such as budget constraints, wood product markets, and forest health problems may necessitate deviations from the scheduled management activities during the ten-year-period.

Public involvement is an important component to the UMP process. We invite the public to comment or express concerns regarding the past or future management of any of the DEC properties included in this UMP. Your comments may be general or specific and will be accepted for inclusion to this UMP until **August 18, 2025**.

Comments will be weighed against law, regulations, DEC Commissioner's directives and other public comments before changes are made to the draft plan. Public questions and/or comments will be included in the Final UMP.

The Department manages State lands for multiple benefits such as good water quality, a diverse and healthy wildlife population, and recreational enjoyment. The plan offers general information on the Unit's history and geology, and an inventory of the Unit's resources, such as vegetative types and stages, fish, wildlife, and habitat. It also describes the proposed goals and objectives along with policy considerations for managing the Unit.

## **Objectives of the Great Divide UMP**

Enhance and monitor wildlife species diversity and protect rare and endangered species of plants and animals. Create a balance of vegetative types and stages by the sale of timber resources, creation and maintenance of grassland and wetland habitats. Monitor for and remove invasive exotic plants and animals.

Comply with Americans with Disabilities Act guidelines for any future increase in recreational facilities. Including all new and replacement gates will be constructed in the saloon style, with a minimum gap of 36 inches.

Best Management Practices for water quality will be used on timber sales, and any other construction activities.

Maintain all parking lots, roads, and related infrastructure, including hazard tree removal.

#### **Translation Available**
