**Bids must be in a sealed envelope, clearly marked "ROAD MATERIAL BID" on the outside, and addressed to the Aransas County Auditor, 2840 HWY 35 N., Rockport, TX. 78382. Bid submittals will be received by the Aransas County Auditor Office until 2:00 p.m. on Tuesday, November 23, 2021, at which time they will be publicly opened and read.** The bids will be considered, awarded or rejected at the Commissioners Court meeting on December 13, 2021 at 9:00 a.m.

Bids may be held by Aransas County for a period not to exceed 60 days from the date of the bid opening for the purpose of reviewing the bids and investigating the bidder's qualifications prior to the contract award.

Aransas County reserves the right to waive or reject any or all Bids or any and all irregularities in said bid(s) and to accept the bid considered most advantageous to the County. The County reserves the right to negotiate with any and all individuals or firms that submit proposals, as per the Texas Professional Services Procurement Act and the Uniform Grant and Contract Management Standards.
