

## NOTICE TO OFFERORS

TPWD is requesting Qualifications and other Solicitation Documents for Design-Build services to perform all Work required for the following Project:

Statements of Qualifications will be received by the Contracting Branch, Infrastructure Division, Texas Parks and Wildlife Department (TPWD), 4200 Smith School Road, Austin, Texas 78744, **until 2:00 p.m., January 24, 2019**

The Project Budget for Phase 1 work is \$10 million. The Project Budget for Phase 2 work is \$4 million. The design-build effort for the Phase 2 work will be added by contract modification if such funding becomes available.

**TPWD is using a two-step process for award of a Design-Build Contract:**

**Step 1, Request for Qualifications (RFQ)**, will result in Owner qualifying a maximum of five (5) Offerors who will be invited to participate in **Step 2**.

**Step 2** will consist of Request for Additional Information as determined by Owner. Although this *Request for Qualifications* generally describes the criteria in Step 2, only short-listed Offerors shall submit a response to Step 2 criteria.

**Oral interviews will be held after Step 2**, to allow offerors the opportunity to highlight the strengths and unique aspects of their responses and provide answers to clarification questions TPWD may have regarding the responses.

**PRE-SUBMITTAL MEETING.** A Pre-Submittal Meeting will be held on January 9, 2019 **at 10:00 AM at Tyler Nature Center, 11942 FM 848 Tyler, TX 75707 at the Nature Center.** Although the pre-submittal meeting is not mandatory, Offerors are strongly encouraged to attend as important information regarding Response requirements and the Project will be discussed.

**SITE VISIT.** A tour of the Site will be conducted immediately following the Pre-Submittal Meeting.
