

Description:

Site work for a playground / park / athletic field in Rockwall, Texas. Completed plans call for site work for a playground / park / athletic field. The Rockwall Independent School District (RISD) is soliciting proposals for the Rockwall High School MultiPurpose Synthetic Field Project per the specifications stated elsewhere in this solicitation document.

Demolition of existing grass surfaces and other miscellaneous features as indicated on the drawings.

Earthwork, including over excavation, select fill, chemical injection soil stabilization, aggregate base material back-fill, compaction and grading and leveling work as required and as specified. Construction of reinforced concrete skirting/retaining walls, flat work other miscellaneous concrete surfaces with aggregate base.

Utility work including storm drain, water and electrical.

Installation of synthetic turf systems including crushed stone under drains.

Installation chain link fence and gates.

Installation of tension wire netting system.

Under Alternate Proposal No. 1, installing electrical boxes and electrical conduits as indicated on the drawings.

Any questions regarding this solicitation must be submitted via e-mail to the Director of Purchasing. In the email subject line type: Questions followed by the solicitation number and title. Q and A and Addenda will be posted online. Bids should be received in sufficient time to be received and time-stamped on or before the published date and time shown on the solicitation document.

Proposers must satisfy themselves, upon examination of these specifications in the pre-proposal conference, as to the intent of the specifications. After submission of the proposal, no complaint or claim that there was any misunderstanding in regard to items listed for proposal will be entertained from either party.

Expensive bindings, color displays, and advertising material are not necessary or desired. Unsigned, unsealed, or late responses will not be accepted. Responses received by hand delivery or mail after the stated due date and time will remain unopened.

Proposal responses should provide straightforward, concise information that satisfies the requirements of this solicitation. Proposals should include all requested and required information. Emphasis should be placed on conformity to the instructions and requirements of this solicitation and the completeness and clarity of content.
