Dear Bidders:

Over the last several years, sellers and buyers have been burdened with the constant and wild fluctuations in fuel and asphalt prices. These fluctuations have made it difficult for the bidder to fairly price products since he/she may be saddled with the stated prices for the twelve (12) month period. Conversely, when fuel and asphalt prices fall, the buyer is stuck with buying a product that now could be purchased cheaper on the open market. In order to better temper the bid process, Aransas County is requesting that the bids submitted be based on the diesel and asphalt prices on the day of the bid opening. Subsequently to the award of bid, price adjustments will be based on the following:

Fuel Surcharge:

Venders may add fuel surcharge to invoices price, which will be bid price of materials, plus fuel surcharge at the time of deliver. Fuel Surcharge shall be bases upon information from the Energy Information Administration's Gulf Coast Region, Oil Price Information Service (OPIS), or an authorized agency monitoring fuel prices. The bidders' preferred rate reference will be stated in the bid sheet along with the initial price for fuel. The reference rate information will be used by the successful bidder for the term of the contract. The fuel surcharge or reduction shall be computed and stated separately on each freight bill or invoice.

Asphalt Pricing and Adjustments

Pricing for asphalt products will remain firm for sixty (60) days increments. The specification provides for a price increase every sixty (60) days, if needed, based upon price changes the bidder receives on liquid asphalt from bid supplier. All bidders desiring consideration of a price increase must supply documentation in the form of current liquid asphalt invoices copies from bidder's supplier showing the average cost per ton for the previous sixty (60) day period. This can result in a price increase or price reduction, depending on the current liquid asphalt price. Bidder will supply the initial price of a ton of liquid asphalt on bid as a basis.
