Roadway reconstruction for Hard Rock Road (3U) from the termination of Phase 2A construction to SH183 frontage road and Pioneer Drive (4D) from the intersection of Hard Rock Road to Esters Road. Hard Rock Road consists of the removal of a existing two lane asphalt street and reconstructing a 41-foot back of curb to back of curb 8-inch concrete street. Pioneer Drive consists of the removal of a two lane asphalt street and reconstructing a 4 lane 10-inch thick concrete street with medians. The reconstruction of these roads includes the replacement of the existing drainage system, illumination, water mains and sanitary sewer mains and the construction of anchored and gravity block retaining walls along with concrete retaining walls required for the project.

The work to be performed under this contract consists of furnishing all materials, appurtenances, tools, equipment, labor and incidentals necessary to install complete in place the major work noted below in addition to other bid items identified in this contract.

- A. Four thousand four hundred (±4,400) LF of 8"-12" water main
- B. Three thousand Three hundred (±3,300) LF of 8"-12" wastewater main
- C. One hundred seventy (±170) LF of 8'x4' reinforced box culvert
- D. Two hundred sixty (±260) LF of 7'x4' reinforced box culvert
- E. One hundred seventy (±170) LF of 6'x4' reinforced box culvert
- F. Four thousand three hundred (±4,300) LF of 15"-48" reinforced concrete pipe
- G. Thirteen thousand three hundred (±13,300) SY of 8" reinf. concrete pavement
- H. Eight thousand six hundred (±8,600) SY of 10" reinf. concrete pavement
- I. Three hundred ninety (±390) CY concrete retaining walls
- J. Four thousand (±4,000) SF concrete block walls
- K. Forty four (±44) EA active rock achors

The above listed work together with all associated appurtenances and other incidental items to complete this project will be installed in the following locations in the City of Irving:

- 1. Hard Rock Road – Termination of Phase 1A construction to SH183 frontage road
- 2. Pioneer Drive – Hard Rock Road to Esters Road
