

**AEC Industry Workforce Development and Training** - Support legislation for funding and initiatives for workforce training and development, immigration/DACA, and local hiring, as well as the equitable treatment and wages of the industry workforce.

**Commercial Construction - Governmental and Education** - Support legislation to fund the maintenance, upgrades as well as new design and construction of municipalities/ agencies and school districts for K-12 and higher education institution.

**Civil Construction-Infrastructure/Transportation** - Support funding and initiatives to repair/maintain, upgrade as well as new design and construction of infrastructure and transportation facilities which will produce construction and engineering contract and employment opportunities.

**Economic Development/Incentives** - Monitor/Support stimulus and other incentives and assistance for small businesses and essential workers, especially construction worker.

**Advocacy for Disadvantaged/Minority/Woman-Owned Businesses Enterprise (D/M/WBES) firms**-Support for supportive services and initiatives to allow D/MWBEs to have access to bidding and opportunities and efforts to maintain and/or enhance existing diversity programs.

**Innovative Alternative Modes of Transportation including High-Speed Rail** - Monitor and Support Legislative Initiative for innovative transportation methods including High-Speed Rail.

**Payment Terms & Lien and Bond Laws** - Monitor and Support state Legislative Initiatives for expedited and prompt payments to small A/E/C Firms and advocate against possible legislation which may create an undue burden on small DMWBE firms.

**Liability Time Frame** - Monitor and Support state Legislation that limits lawsuits on 10-year liability time frames to contractor firms.
