General Scope of Work: Part One includes replacing asphalt composition roofing at 11 buildings, miscellaneous carpentry repairs and painting, replacing roof framing at one building, and adding a canopy at one building. Part Two includes replacing asphalt composition roofing with wood shake roofing and miscellaneous carpentry repairs and painting in accordance with the Invitation for Bids and Contract Documents.

Project Schedule: All work shall be completed within three hundred sixty five (365) calendar days commencing on the date specified in the Notice to Proceed.
