Sealed Bids for the construction of the **North Magee Street, North Manry Street, and Callahan Street Improvements - TxCDBG No. 7219180** will be received, from all interested Bidder's, by the City of Groveton, at the office of the Mayor, Byron Richards, P.O. Box 37, Groveton, Texas 75845, until 2:00 P.M. local time on **Friday, May 29, 2020**, at which time the Bids received will be publicly opened and read. The Project consists of constructing **street improvements including sawcutting, pulva-mixing and treating existing base and pavement material, and installation of hot mix asphaltic concrete pavement.**

Bids shall be on a lump sum and/or unit price basis, with additive alternate bid items as indicated in the Bid Form.

Bidders will be allowed to modify or withdraw bids prior to the scheduled closing time for receipt of bids. No bid received after the scheduled closing time will be accepted or opened. No bid may be withdrawn after the scheduled closing time for receipt of bids for at least 60 calendar days.

The successful Bidder, or Bidders, will be required to furnish a Performance Bond and Payment Bond each in the amount of the contract written by a responsible surety company authorized to do business in the State of Texas and satisfactory to the Owner.

The award will be made on the basis of the lowest responsive bid. The City reserves the right to waive any informality in the bidding and to reject any or all bids.

Attention is called to the fact that not less than, the federally determined prevailing (Davis-Bacon and Related Acts) wage rate, as issued by the Texas Department of Agriculture Office of Rural Affairs and contained in the contract documents, must be paid on this project. In addition, the successful bidder must ensure that employees and applicants for employment are not discriminated against because of race, color, religion, sex, sexual identity, gender identity, or national origin. Adherence to the grant recipient's Section 3 Policy is required for contracts and subcontracts in excess of \$100,000.00.

Attention is called to the requirements for ensuring that employees and applicants for employment are not discriminated against because of race, color, religion, sex, sexual identity, gender identity, or national origin, and other civil rights requirements.

All contractors/subcontractors that are debarred, suspended or otherwise excluded from or ineligible for participation on federal assistance programs may not undertake any activity in part or in full under this project.
