Bid will be received by the Aransas County until **2:00 p.m. on Tuesday, February 27, 2024** at which time they will be publicly opened and read aloud.

The Invitation for Bid results will be announced at the Commissioners Court meeting on Monday, **March 11, 2024 at 9:00 a.m.**, at which time the bid will also likely be awarded.

Location and Time of RFP Opening: Bids will be opened at the Aransas County Courthouse, 2840 Hwy 35N, Rockport, TX 78382, on **Tuesday, February 27, 2024 at 2:00 P.M.**

Questions and Clarifications: Interested parties may submit written questions and/or requests for clarification no later than **Tuesday, February 06, 2024 by 10:00 a.m.** Questions and clarifications will only be accepted in writing and must be emailed to the Contracts and Procurement Specialist, Eric Smith at esmith@aransascounty.org. All questions and answers will be distributed to prospective bidders by email and/or by posting on Aransas County's website www.aransascountytexas.gov on the Aransas County Public Notices Page.

A copy of the Bid Packet can be obtained free of charge during regular business hours in the Contracts and Procurement's Office at 2840 HWY 35N, Rockport, Texas, 78382 and on Aransas County's website at www.aransascountytexas.gov. The Courthouse is closed from 12:00 p.m. – 1:00 p.m., Monday through Friday.

No bid may be withdrawn for at least **Sixty (60)** days after the scheduled opening. Aransas County reserves the right to change the date of the opening, to waive any informalities, and to accept the bid deemed most advantageous for Aransas County. Section 3 Residents and Business Concerns, Minority Business Enterprises, Small Business Enterprises and Women Business Enterprises are encouraged to submit responses.

In order to be eligible to bid, bidder must not: be debarred or suspended from government bids; boycott energy companies; boycott Israel; engage in business with Iran, Sudan, or a foreign terrorist organization; be or be associated with a company that is majority owned or controlled by citizens or governmental entities of China, Iran, North Korea, Russia, or any other country designated by the Governor of Texas, or headquartered in any of those countries; be otherwise excluded from, or ineligible to participate in federal or state assistance programs.
