- We will have two staging areas for 15-minute presentations which will be held either in the Avalon Banquet Room or the Key Largo room. A podium and microphone will be available for use. Casual seating (tables, high tops) will be available in the room. Sessions in a private meeting space will have a podium, screen, microphone, formal seating. Topic must be home & garden related and approved by organizers.
- All exhibits must be confined within exhibit space. No wall hangings or backdrops permitted. Only literature or products that fit upon or within the assigned space may be displayed. Displays **may not exceed 6 feet in width**. Please note that some booths/tables will be placed against the wall depending on location and need. Provided tables are six feet in length. Exhibitors may not bring extra tables, as all display tables will be skirted previously.
- 110v electrical outlets are limited and are distributed on first come; first serve basis. **Exhibitors must supply own extension cords.**
- Exhibitors are encouraged but not required to offer special discounts/packages/coupons of their products or services for Expo attendees. These offers should be valid for at least a month after the Expo date.
- Exhibitors may sell their products or services at the Expo but via their own register system.
- Set-up will be available beginning at 8 AM on Feb. 8, 2020.
- The exhibit hours are 10 AM to 4 PM Saturday (Feb. 8). Please have your booth completely set up by 9:30 AM Saturday Feb. 8 and be stationed at your booth prior to 10 AM. Your booth should be staffed at all times. Failure to show by 9:15 AM on Saturday (Feb. 8) will result in the cancellation of your space. Tables cannot be disassembled until after 4 PM Saturday but **must be completed** by 5 PM. **NO** early breakdowns permitted.
- **PLEASE NOTE:** Spaces are limited and reserved only upon receipt of the properly submitted payment unless previously authorized through the Chamber. Assignment of exhibit space will be based upon date of receipt & payment of the Home & Garden Expo registration contract. Absolutely **no refunds** will be given for space rentals for any reason.
