Donald Trump Will Raise Costs for Seniors.

PRESIDENT BIDEN AND VICE PRESIDENT HARRIS ARE FIGHTING FOR AFFORDABLE HEALTH CARE FOR AMERICA'S SENIORS.

- ✓ **Capped insulin costs at \$35 per month** and are limiting out-of-pocket prescription drug expenses to \$2,000 for seniors and other Medicare beneficiaries.
- ✓ **Guaranteed free vaccines for Medicare Part D beneficiaries resulting in more than 10 million enrollees receiving a free vaccine**—an increase from just 3.4 million enrollees in 2021.
- ✓ **Made hearing aids cheaper and available over-the-counter without a prescription**, lowering average costs by as much as \$3,000 a pair.
- ✓ **Pushed three of the four largest inhaler manufacturers to cap the cost of inhalers at \$35 per month**, saving as much as thousands of dollars per year for the 27 million Americans with asthma.
- ✓ **Stood up to Big Pharma and won:** Empowered Medicare to negotiate drug prices directly with pharmaceutical companies—getting seniors and people with disabilities better prices for the same drugs.

Donald Trump wants to enrich Big Pharma and corporations while raising costs for seniors:

- ✗ **Trump supported plans to end Medicare as we know it.** He has plans to slash Medicare funding, threatening the health and wellbeing of 67 million seniors.
- ✗ **Not one Republican voted for President Biden's legislation that gave Medicare the power to negotiate drug prices.** Now, Trump and extreme MAGA Republicans want to repeal these provisions—making Big Pharma richer.

PRESIDENT BIDEN AND VICE PRESIDENT HARRIS ARE FIGHTING TO PROTECT AND STRENGTHEN SOCIAL SECURITY AND MEDICARE:

- ✓ **Americans have been working their whole lives, and paying into Social Security and Medicare.** President Biden and Vice President Harris firmly believe that the benefits of these programs belong to the American people.
- ✓ **President Biden has been clear: He will always protect Social Security and Medicare from MAGA Republican attacks.** The president also believes that strengthening Social Security and Medicare should start by making the wealthy pay their fair share.

- ✗ **Trump has called Social Security a "Ponzi scheme."** He has a long track record of trying to undermine the financial security of the 50 million seniors who rely on it.





PRESIDENT BIDEN AND VICE PRESIDENT HARRIS ARE FIGHTING TO PROTECT SENIORS' HARD-EARNED RETIREMENT SAVINGS:

- ✓ **President Biden and Vice President Harris are standing up to special interests and protecting retirement savings** by cracking down on expensive and excessive bank fees.
 - ✓ **President Biden and Vice President Harris took action to penalize financial advisors who cost seniors tens of thousands of dollars in retirement savings** by prioritizing their own commissions and fees rather than seniors' investment needs.
 - ✓ **Unlike Donald Trump—who looked union leaders in the eyes and lied, claiming he would save their hard-earned pensions—President Biden actually got it done.** President Biden signed legislation to save and secure the pensions of hundreds of thousands of union workers and retirees.
- Donald Trump will let his Wall Street donors jeopardize Americans' hard-earned retirement savings:
- ✗ **Trump wants to eliminate protections** for Americans' retirement savings from expensive, hidden bank fees.
 - ✗ **Trump wants to make it easier for companies and banks to rip off seniors** by undermining America's consumer watchdog, the Consumer Financial Protection Bureau.
 - ✗ **While in office, Trump asked Congress to cut the retirement benefits of nearly 3 million Americans** who work as public servants, including eliminating cost-of-living increases.

- ✓ **In their first few months in office, President Biden and Vice President Harris boosted funding for home care programs for America's seniors**, shortening the waitlist to access these services.
 - ✓ **They are requiring nursing homes to increase the number of staff available** to care for older Americans.
 - ✓ **President Biden and Vice President Harris know there is still more work to do to ensure seniors and their families have access to quality, affordable long-term care.** That's why they are fighting to permanently expand home care services for seniors through Medicaid.
- Donald Trump wants to cut long-term care services for seniors:
- ✗ **During his presidency, Trump proposed cuts** to programs that help seniors access long-term care.
 - ✗ **Now, he plans to cut Medicaid**, which provides home-based care, and has no plan to expand access to long-term care, support family members who care for their loved ones, or make care more affordable.
 - ✗ **As president, Trump reduced infection prevention protections in nursing homes, contributing to COVID-19 deaths**, while also making it harder to hold bad-actors accountable for harm to senior residents.

Donald Trump will prioritize the interests of billionaires, Big Pharma, and insurance companies over America's seniors, raising costs on everything from prescription drugs to health insurance to long-term care. President Biden and Vice President Harris are fighting to ensure that every American can age with the respect, dignity, and financial security that they deserve.
