

2020 Arizona Region Girls National Club Qualifier

To be eligible to participate in the AZ NCQ tournament (if play happens) or receive a bid from the Arizona Region or a reallocation bid from USAV this entry form must be submitted to the Arizona Region office no later than 5 pm on Friday, May 15, 2020 for all teams. Late entries will not be accepted. Should the tournament be played, the club will be charged \$390/team. A date and time to play are still to be determined as insurance suspensions continue to roll forward.

The Club Director of this team must initial each section to indicate they have read and understands the info in this box. Clubs with a balance due will not be allowed to enter teams in this tournament.

_____ Teams must confirm with their players and parents prior to entering the event that this is a viable team that is committed to attend the GJNC in Dallas, TX, June 23 - July 4.

_____ Only those players that are committed to attend are allowed to participate in the tournament. In this very unusual year, USAV is loosening up the transfer rule for players (with Region approval) - between teams in the same club and/or between clubs. Therefore, any team or club changes must be accomplished prior to May 15.

_____ There are many concerns for teams to attend the GJNC for 2020. With that, it is possible there may be a need for more reallocation or At-Large bids to be filled causing trickle-down bids in Arizona.

_____ The teams that place 1st in each age division will receive the bid to the National Division of GJNC. The teams that place 2nd in each age division will receive the bid to the American Division of the GJNC. The teams finishing 3rd - 6th are alternates and are required to remain committed to attend the GJNC until ALL USAV reallocation bids have been filled and no AZ teams may advance further. Any team that does not have a bid, finishes in an alternate position and passes on any bid that comes to the Region will be sanctioned by the Region. The sanction may be financial and/or participatory in nature and will carry over to the next season, if applicable.

_____ All Qualifying Teams: Once a bid is received, the GJNC entry must be completed in AES and the entry form and fee submitted to USAV within 10 days of qualification. All Alternate Teams must enter AES in the American Division and submit entry form and fee (payable to the Arizona Region) to the AZ Region office within 10 days of qualification. The entry fee will be paid by the club in AE upon a bid acceptance and the check will be destroyed by the Region OR the Region will deposit the check if the club passes on the bid offered. USAV will change the division level of a team in AES when all the qualification and reallocation bids are completed.

_____ With the continuing restrictions on participation and unknown date as to when teams may begin training and practicing again, it is understood that this event may not take place. If the AZ NCQ is unable to be played on the court, the teams that have entered will be ranked by age based on their last finish in an AZ Region tournament and bids awarded for places 1-6 in each age group. If the NCQ tournament is not held, all entry fees will be refunded. Teams that do not enter the AZ NCQ will not be considered for a bid.

_____ Teams withdrawing after the deadline will not receive a refund.

The undersigned hereby states: 1. The above team, its players, coaches and chaperones are registered members of the Arizona Region of USA Volleyball for 2020., 2. The above team, its players, coaches and chaperones should have read carefully and meet the eligibility rules applying to USA Volleyball play. 3. No players with an age waiver will be participating in this tournament unless the team is attempting to qualify and participate in an older age group. 4. All coaches on the roster are SafeSport trained and current IMPACT or CAP certified per AZ Region requirements. 5. All players and coaches participating in the AZ NCQ with this team will be attending the GJNC with this team.
