# Cancer screenings available for women at CRMC

Free breast and cervical cancer screenings will be offered at Cuyuna Regional Medical Center's Crosby Clinic on Tuesday, Nov. 9, from 5 to 7 p.m. for uninsured and underinsured women aged 40 years and older who meet income guidelines.

At the event, eligible women will receive clinical breast examinations, mammograms,

Pap tests, pelvic examinations, Human papillomavirus (HPV) tests, diagnostic testing if results are abnormal, and referrals to treatment. Family Physicians Holmgren, M.D., and Hannah Elsenpeter, M.D., are volunteering their time to assist women.

CRMC hopes to make more women in the Cuyuna Lakes Area aware of this free pro-

gram. "We think many women are not receiving these life-saving screening tests because they have no health insurance or their insurance has deductibles or co-payments they cannot afford to pay," said Oncology Care Coordinator Dustine Parks, R.N.

All women are at risk for breast and cervical cancer, but regular screenings can pre-

vent these diseases or find them early. Women between 40 and 74 years old should get a mammogram every year. Women should get their first Pap test at age 21 and continue screening until age 65.

Light refreshments will be served at the event and ladies will receive a swag bag. For a screening appointment, call 218-546-7000, ext. 2135.

# Essentia Health reinstating visitor restrictions across all hospitals

Essentia Health is reinstating visitor restrictions at all of our hospitals due to increased transmission of COVID-19.

In most cases, two adult visitors will be allowed per patient, per day. Visitation is limited to the same two people in a single day.

Patients with known or suspected COVID-19 are not allowed visitors unless they are pediatric or OB patients, or patients in an end-of-

life situation. A person who has been determined to be essential to the care and safety of a patient will also be allowed visitation.

General visitation hours in the hospital are from 9 a.m. to 6 p.m. When visitors are care

partners or are visiting in emergency departments, pediatric inpatient units and neonatal ICUs, visitation is allowed 24/7.

There are exceptions to this policy for several situations. A complete visitor policy can be found on the Essentia

Health website.

Essentia continues to follow Centers for Disease Control and Prevention and state health department guidelines by requiring continuous masking among everyone within our facilities and by screening

patients and visitors. We ask visitors to remain in the room of the patient they are visiting.
