6. Standing Rules of Order
The Parliamentarian presents the Standing Rules:
 - Rule 1: Only delegates may be seated in the designated delegate area.
 - Rule 2: Only delegates may present motions, speak, and vote.
 - Rule 3: Delegates may leave and re-enter; ballots must remain in the House. Ballots must be surrendered upon exit and returned upon re-entry. Missed votes cannot be cast later.
 - Rule 4: The maker of a motion speaks first or may yield to another delegate.
 - Rule 5: Delegates may speak for up to two minutes unless extended by majority vote.
 - Rule 6: No second speech on a motion until all others have had the opportunity.
 - Rule 7: Delegates may speak twice on a motion in one day.
 - Rule 8: Speaking time cannot be transferred or accumulated.
 - Rule 9: A delegate may not both debate and move to close debate in the same recognition.
 - Rule 10: The chair alternates between speakers for and against a motion.
 - Rule 11: Delegates must wait until a speaker finishes before seeking recognition.
 - Rule 12: All remarks are directed to the chair, not to other members.
 - Rule 13: Motions/amendments must be written, signed, and submitted before being presented.
 - Rule 14: Withdrawal of a motion requires majority approval of the House.
 - Rule 15: Robert's Rules of Order, Newly Revised, governs procedures not otherwise specified.
