COMMUNITY UPDATE 2018



Evans is fighting to reform our criminal justice system. Evans backed reforms to help reduce the cycle of senseless crime by providing rehabilitation and opportunity for those that have served their time.

Evans voted to provide \$350 million in new funding for our schools. He worked with Republicans and Democrats to ensure the state is meeting its full obligation to our schools, helping to provide our children with a world-class education and taking a critical step toward property tax relief.

Evans passed a bipartisan, balanced budget. Working with Republicans and Democrats, he passed a budget package that holds the line on taxes and spending, and creates a surplus to help pay down old bills. Evans worked to cut government waste and bureaucracy in order to invest in our schools and programs that keep our families safe from gun violence, and reverse Governor Rauner's extreme cuts to health care, child care, and senior services.

Evans is fighting for a Fair Tax that requires the ultra-wealthy to pay their fair share. Evans backed a proposal urging Illinois to cut taxes on working families while requiring millionaires and billionaires to pay their fair share. A Fair Tax will provide more resources for our neighborhood schools and fund vital services like child care and home health care services.

Evans is fighting to keep dangerous weapons off our streets. He fought to crack down on deadly military-style assault rifles, ban bump stock modifications that turn semi-automatic weapons into fully automatic firearms, and hold gun dealers accountable to ensure dangerous criminals and those with a history of mental illness or domestic violence cannot obtain guns.
