Coronavirus (COVID-19) Update

Bald Head Association extends its wishes for everyone to stay safe and encourages all members to continue following current recommendations about coronavirus (COVID-19) from credible sources. Now is the time to put in place necessary preparations and to listen to governmental leaders who have the safety of all citizens in mind.

We want you to know that BHA continues to work and serve its property owners and will continue to work and communicate with our valued vendors.

The key to “flattening the curve” of COVID-19 infections is to avoid person-to-person contact. Acting in a prudent manner to lessen the chance of spreading this virus and for the safety of property owners, members and staff, BHA is canceling all activities/events in the Association Center through March 31st. At that time, the BHA Board will re-evaluate and determine if additional cancellations are necessary.

The BHA office will operate with limited hours beginning Tuesday, March 17, 2020. Office hours will be Monday-Friday from 10:00am-1:00pm. Homeowners are encouraged to have contractors needing to pick up keys to their homes call ahead (910-457-4676, ext. 21) to identify needed keys. Keys will be provided in a sealed envelope with your information on it and left just outside the front door during office hours only. Returned keys can be left in the secure drop box beside the office front door.

Also beginning Tuesday, March 17, 2020, all activities and meetings in the Association Center (both in the downstairs Generator Society Hall and upstairs in the Berne Conference Room) will be canceled through March 31st. This allows us to thoroughly clean to help prevent any contamination.

As the municipality, the Village of Bald Head Island is coordinating emergency efforts with county and state authorities, as well as with BHI Limited and the US Coast Guard regarding any ferry issues that might impact BHI property owners. The Village Council's regular monthly meeting will be held on Friday, March 20th, and BHA will provide relevant information that is available during the public meeting.
