U.S. Truckers Gearing Up For Convoy To D.C. In 2022

Hot on the heels of the convoy of Canadian truckers, multiple efforts to stage a similar convoy in the U.S. have emerged. Brian Brase, a truck driver from Ohio, is one of the core organizers of a group planning the Convoy to D.C. 2022. Brase said the organizers are finalizing their plans and do not have a specific date or routes they are prepared



to disclose as of publication time. However, they did put a hard deadline of March 1.

“If it doesn’t happen before then, it will happen March 1,” he told Land Line.

Brase said his group is not the only one organizing convoys. However, he said most of the groups are working together “for the most part.”

“There are multiple groups trying to make this happen, and we’re working together for the most part,” Brase said. “We encourage them all to come to the table. If ours starts first, we hope they will join. If they start first, we’ll jump in on theirs,” Brase said. “This is bigger than any one person, company or organization.”

Brase said the convoy is organizing to protest vaccination mandates. He stressed it is not an anti-vaccination movement but rather about “human and constitutional rights.”

“This isn’t about the trucking mandates. There’s so much more in play there. We are just truck drivers standing up for our human rights, and as Americans it’s about our constitutional rights,” he said. “It’s about a human being deciding what gets injected into them. We’re not about shaming people who aren’t vaccinated or shaming those who are. It’s about choice.”

The vaccination mandates in the private sector and at lower government levels are hindering access to healthcare, education, and law enforcement, to name a few basic needs according to Brase.

“There are good people, good teachers, good nurses, good police officers losing their jobs over these mandates,” he said.

That, Brase contends, threatens access to basic services and the quality of the lives of truckers’ families left at home while they are on the road.

Brase stresses that this is not a partisan issue and that those supporting the convoy are diverse politically, racially and by gender.

The Owner-Operator Independent Drivers Association is in opposition to vaccination mandates, but rather supports personal choice on vaccination.

And, while the Association supports lawful protests, it is prohibited from calling for strikes because of anti-trust laws.

He also is stressing the need for all participants to conduct themselves peacefully and lawfully.

“We’re coming together as humans,” he said. “The bottom line is that the attendees of this convoy/protest are expected to carry themselves professionally and peacefully. We’re not there to cause mayhem and trouble. This is a peaceful convoy across the nation to restore our constitutional

rights.”

The Convoy to D.C. 2022 organizers are planning to start the convoy from multiple locations in California. There will be other convoys originating in Texas, Florida and Maine, to name a few. Brase said all convoys will ultimately converge in Washington, D.C.

Announcements of the convoy’s routes and dates became problematic on Feb. 1 when Facebook removed the group’s page from the service. According to a statement issued to “Fox and Friends” by Facebook, the group had violated multiple community standards related to QAnon. Brase patently denies those violations but concedes Facebook’s rights to remove groups and individuals from its service.

“You can’t want freedom from mandates and then stand against Facebook for removing stuff when that’s well within their rights,” he said. “But we will keep getting the word out.”

Only a Government With Consent of the Governed

The very foundations of our government were spelled out from the very beginning by the Declaration of Independence. “We hold these truths to be self-evident. That all men are created equal, that they are endowed by their Creator with certain unalienable rights, that among these are life, liber-

ty, and the pursuit of happiness. That to secure these rights, government are instituted among men, deriving their just powers from the *consent of the governed*.”

Consent is permission. *You* gave them consent to do what they do. *You* gave them consent to treat you how they treat you. *You* gave then consent to take your money and give it to someone else. *You* gave them consent to take your property. *You* gave then consent to enslave your children with massive debt. *You* gave them consent to pass laws that have nothing to do with the Constitution.

In fact, *you* gave them permission to do a lot of things. Everything the government does is because *you* gave them permission to do it. So, when did you give your consent? When did you give them permission to bankrupt the country, devalue the dollar and spend millions of dollars every year? When do you give them permission to take people’s property as they see fit? When did you give them permission to take over the healthcare industry and require your compliance?

Did you Consent to those things?

Consent can be given either explicitly or through acquiescence. Explicit means “fully revealed or expressed without vagueness, implication or ambiguity: leaving no question as to meaning or intent.” To *acquiesce* means “to accept, agree, or allow something in happen by staying silent or by not arguing.”

It is important to remember this key point. *Everything* the government does to you is by your consent. You either explicitly give them consent, or by your silence, *they assumed* your consent.

At some point in time, you either signed a document giving away your natural God-given rights or when they took them and you said nothing, they assumed they had your permission. It’s imperative we make a concerted effort to reclaim our natural God-given rights and rethink how and when we give our consent of the governed. In every interaction with the government, no matter local, state, or federal, we must understand what we are signing or what consent they may be assuming.

In fact, the Constitution demands the government look to the people for that consent and the best part is that it’s supposed to happen *on a daily basis*.

After watching the nasty and downright dishonest partisan political theater around Jan. 6, 2021 attacks, and the effort to change voting laws, it’s obvious America needs an entirely new conversation about its challenges and its future.

As Americans who love our country it is difficult to disengage from the mean-spirited, constantly vicious, personal, and negative environment that the current political promotes. It’s even harder to ignore the constant pettiness of the news media and, with few exceptions, the shallow agendas of the reporting community. However, the viciousness and negativity of attack politics is the opposite of what America wants.

Washington avoids reality by focusing on the politics of politics, personality fights, and the trivia of ambitious people seeking publicity. The hunger of the news machine can be fed without ever getting close to substance and or historically important questions. Tragically, this politics of nasty, negative noise is gradually killing America.

Americans face enormous historic challenges far beyond the ability of the current news media/politician dance of ambition, partisanship, and trivial negativity.

We’ve been successful and powerful for several generations, so it’s easy to forget our success was based on identifying, analyzing, and solving real problems. America was fortunate in key moments by having leaders who could look beyond the next headline, overlook partisanship and personality conflict, and focus on what mattered. If America is to remain free, safe, and prosperous, we’ll have to elevate our national debate far above the current pattern. 1. Communist China is the greatest foreign threat to American survival. Congress should focus relentlessly on every aspect of the Communist Chinese challenge.
2. The pandemic has revealed a stunningly incompetent public health system whose failures may have led to 500,000 or more American deaths. And nothing has changed! The next pandemic and biological warfare remain a realistic possibility.
3. The K-12 school system is an abject failure incapable of competing with either China or In-

dia. We are ruining our children’s lives and threatening our national security.

4. In-sourcing all vital manufacturing should be a major lesson of the reliance on China for pharmaceuticals, solar power capabilities, computer chips and a host of other products. And the re-designing of our tax system to keep us competitive should be a major goal.
5. The entire system dealing with illegal immigration has been destroyed.
6. The expansion of pervasive discrimination has been a shocking violation of more than seven decades of effort to end segregation and move toward an integrated America to provide equal opportunity for all. None of this has been supported by the American people.
7. The flood of District Attorneys who refuse to prosecute crime has led to an extraordinary rise in violent crime.
8. Balancing the budget is a requirement for our long-term health as a country.
9. The spread of nuclear weapons requires a dramatic increase in our focus on domestic defense.
10. Our national security system—the Department of Defense, 18 Intelligence Agencies, the State Department, and key elements of the Justice Department – are collectively an incompetent mess. We’re drifting toward a catastrophic defeat unless we rebuild and take decisive steps to rethink and rebuild our national security system.
11. Finally, we face a crisis in mental health, suicide, drug addiction and homelessness. More than 100,000 people died from drug overdose last year and 45,000 or more American citizens committed suicide in 2020. In Los Angeles alone, there are an estimated 67,000 homeless people. This reality requires a seriously deep and focused response.

Take these eleven serious realities—which threaten lives, safety, and freedom of the American people – and then watch the current political news media theatre. You will understand the contrast between the futile arguing into which we are trapped and the honest adult conversations we need.

America’s survival depends on moving away from the narrowly political and toward the historic in our national politics.

Even the olive and the cactus, those fast friends of a worthless soil, had almost deserted the country.”

Prior to the return of the Jews, the desert began greening and today provides 100% of the food for Israel. The nation has also become one of the world’s major exporters of fruits and vegetables.

Ezekiel 37:11:13, *“Now give them this message from the Sovereign Lord: O my people, I will open your graves of exile and cause you to rise again. Then I will bring you back to the land of Israel. When this happens, O my people, you will know that I am the Lord.”*

Fulfillment: Beginning in 2015, there was a great increase in the number of Jews making the choice to move to Israel. Bible prophecy tells us that in the last days Jews from all over the world will return to Israel.

Why this is coming uniformly from their side and not from conservatives is impossible for them to deny or explain.

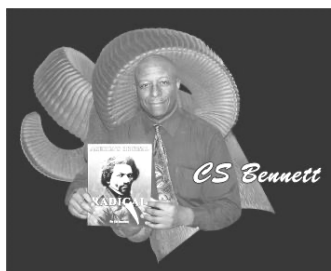

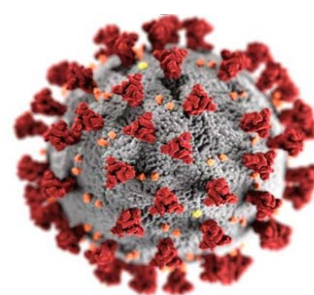

The greatest government failure in American history

The tally for how much the federal government spent to combat COVID-19 is now estimated to be \$5 trillion. It is more than the combined costs of



World Wars I and II. The left is celebrating that politicians in Washington saved us. Really? From what exactly?

Two years later, it is time for an honest assessment.

Could things have worsened for the country if the government had spent nothing and done nothing? What would have happened if we had not shut down our businesses? Our churches, schools, and restaurants. Our parks, basketball courts and playgrounds.

Would the public have made worse decisions regarding protecting its health and the health of its families and its employees than the politicians have made?

The left believes that it was government intervention that saved millions of lives. But even with all the federal spending, some 879,000 (and counting) have perished from the virus. It was politicians such as New York Gov. Andrew Cuomo whose awful decision-making contributed to the deaths of thousands of seniors exposed to infected patients in nursing homes. In addition, politicians didn't shut down the New York subway system for many weeks into the virus, costing thousands more avoidable deaths.

Suppose the government is here to save us. How do we explain the shameful malfeasance of the CDC, the FDA, the NIH and other government medical agencies and programs that spend roughly half a trillion dollars each year to keep us healthy? All that money couldn't stop a virus from wreaking havoc on the country for two years and counting.

Why was the CDC caught entirely unprepared to fight this virus? It would be like a town spending millions of dollars a year on fire protection, and the first time there is a significant fire, the firefighters are all napping, no one slides down the poles and the fire engines won't start. So, what were Dr. Anthony Fauci and the rest of the experts at the CDC doing with the tens of billions of dollars we give them each year? They studied the health effects of liberal obsessions such as climate change, racism, and gun violence. What they weren't ready to do was their job: preparing for infectious diseases.

Then there is the question of what Washington did with all the money. At least \$2 trillion was given to workers and businesses to compensate them for the lockdowns that the government itself imposed. We now have pretty conclusive evidence from dozens of country and state studies that lockdowns were a highly ineffective way to combat the virus. Lockdowns may have saved some lives, but this response was the equivalent of trying to remove a tumor with a sledgehammer. Age-adjusted death rates were no lower in states that shut down their economies than states that stayed open.

The rest of the money went to pay school districts even though the school doors were locked shut, to fund states and cities that closed their businesses, to fund mass transit trains and buses that operated nearly empty, and worst of all, to fund hundreds of billions of dollars of welfare programs, such as expanded unemployment benefits, that paid workers to stay off the job. And millions of workers still haven't come back.

The one program that did work was President Donald Trump's Operation Warp Speed. But the heart of that program was to find ways to pull end-runs around drug and vaccine regulations that hold up lifesaving medicines for many years. As a result, private companies such as Pfizer invented the vaccines in record time because the government stayed out of the way. (See **FAILURE** page 4)

We are still paying a high price for President Joe Biden's screw-ups as we deal with the less deadly omicron variant. Late last year, Biden's Department of Health and Human Services stopped all shipments of an effective COVID-19 treatment by Regeneron because a CDC model concluded wrongly that the delta variant had disappeared. Thanks to that blunder, many thousands died or were hospitalized because the government denied them treatment. Other promising therapies, such as by GlaxoSmithKline, have run into regulatory hurdles preventing or delaying their use.

Wouldn't it have been more competent and more humane to let doctors and patients make these decisions rather than Washington bureaucrats and politicians?

There have been a multitude of other snafus by the government that only validate the utter incompetence of big government. Some \$300 billion was stolen by fraudsters who ripped off the Medicaid and unemployment benefits programs.

Now here we are, two years from the start of COVID-19, closing in on 1 million dead and \$5 trillion more in debt. Millions of children have suffered, perhaps irreparably, from a loss of schooling (some of which still goes on in some districts). There are some 50,000 to 100,000 deaths of despair caused by the lockdowns. And the virus is still out there, though thankfully in retreat.

Big government didn't save us. On the contrary, big government has left us weaker as a nation in every way, and we will spend decades cursing the fact that we panicked and handed over so much power to so many incompetent people in Washington.

This Revolution Started Decades Ago, and We've Been Blind To It

They caught me sleeping. But never again. I thought I had my eye on America's shifting culture. I'd seen its troubling new realities: gay marriage, university grievance studies, snowflakes on campus, socialism, Black Lives Matter, and more. But I hadn't seen what tied it all together.



I'd put it all down to human pride, greed, and appetites out of control, including the lust for power— old-fashioned sin, with ignorance in there to boot, the kind that comes from intellectual and moral laziness. I've said the Church has been complicit in it, through apathy and sin. I said that, and I am quite sure I was right as far as it went. Still, I missed seeing how far that really was going to take us. So did you, I'll bet we all missed it.

It finally hit me when I read: *Critical Race Theory: The Key Writings That Formed the Movement*. The first thing I looked at was the copyright page, to see how recently this critical race theory movement had come along. How long do you think CRT has been out there, building momentum in academia? I'll give you some help. Recent books on *White Fragility* and *Anti-Racism* aren't exactly classic CRT. They're more like intellectual descendants, building on it and extending it. They've had so much influence, though, they've changed the vocabulary. I think it's perfectly fair tho to call them all part of CRT. At the

same time I know that some Crits (critical race theorists) would tell you they really intended it strictly as legal doctrine. This book collating "the key writings that formed the movement" was published in 1995. Yes, that long ago. It opens with two articles from the late 1970s by CRT's acknowledged founder, Harvard professor Derrick Bell. This has been coming at us for decades.

There's another movement behind the movement, though, and this goes back further. Critical theory was born out of Frankfurt, Germany the Institute for Social Research. The institute was started by a few wealthy Jewish families who together decided the world needed the salvation Marxism could offer. Hitler forced them out of Germany, so these thoroughly Marxist academics came to America, establishing an institute at Columbia University in New York, its members became known as the Frankfurt School.

Herbert Marcuse became their most famous representative, teaching theory supporting sexual liberation. The school's first director, Max Horkheimer, argued that even formal logic — rational, logical thinking — was a tool of oppression. The entire school was all about liberation. They poured great energy into understanding the 20th century's great Marxist mystery: Marx had expected the proletariat, the common people, to rebel against their bourgeois capitalist oppressors everywhere. Instead, strangely, they seemed to be getting happier. Over decades, their pay increased, and conditions got steadily better. Reforms seemed to numb them to the horrible, alienating way the system abused them. How could this be? The explanation, these intellectuals decided, lay in the people's false consciousness: They were so happy, they didn't know they were oppressed! Sexual "Oppression," Family "Oppression," any "Oppression" it takes to foment revolution. Marcuse thought liberation lay in freeing up "the pleasure principle" — for that a sexual liberation was needed. Sex whenever, wherever, and with whomever — which is only a mild exaggeration. Others said the sleeping victims of oppression needed awakening, and if economic "injustice" didn't do the trick, they'd raise alarms of a racist oppression, sexist oppression, heterosexist oppression, patriarchal oppression, "ableist" meritocracy oppression, "nativist" oppression. Any oppression they could come up with, they found it and they've used it.

Was it all for the good-hearted purpose of helping people feel more miserable, by way of suddenly discovering they were among the oppressed? No, that wasn't the purpose, though it was crucial to the goal. The real end these critics sought was always to foment Revolution.

Marx and Engels argued that the family was a "tool of capitalist oppression, and needed to be abolished," as Stuart Jeffries wrote it in his intellectual history of the Frankfurt School. Those two kicked it off, and since then it's been all revolution, all the time. The revolution didn't happen the way Marx had expected, and that drove Frankfurt School members "to reconfigure Marxism," says Jeffries, "and develop interdisciplinary critical theory: the revolution hadn't occurred, and it was imperative to work out why."

Crucially, they never had to prove their theories of oppression. They only had to find the rhetoric that would stir up enough people to start throwing things. And lighting fires. And "defunding" the force that could protect the rest of us from them.

There's no answer now but Counter Revolution. We must change how we think of our homes and churches. Of course, they still have their purpose as centers of rest, of growth, of love, of healing. Now, though, they must also be centers of revolution. We have but one defense now, and it is a counter-revolution — spiritual counter-revolution, a revolution of the heart, through Christ, extending through our families and churches, and into all of culture. We must defend and promote the truth about God's plan for man within the church, our families, our forms of education-everywhere as an act of spiritual warfare.

I mean that quite seriously. Please do not think of this as some bland religious thing. Do not think of it as church as usual. Men of the Church, we

must see ourselves as guardians and as warriors, teaching truth, holding lies at bay, praying and living and teaching the revolutionary life of Christ. Yes, we must change how we think of our homes and churches. They must become centers of revolution. It starts with us, and our own commitment to following Christ into a nation that's rushing pell-mell into violent, destructive rebellion. We've let the left have its way too long. **No longer. OK?**

Is Stealing Wrong? Not on the Left

To most readers, the question is absurd. The reason is not because the question is, in fact absurd, it's because most readers of this column are conservative, and many are religious. Am I implying that most leftists do not believe stealing is wrong? Yes, I am.



As incredible as this assertion is to just about all religious people and virtually all conservatives most leftists believe stealing is wrong. Since I always draw a distinction between those on the left and liberals, let me add that I suspect most liberals think stealing is wrong. But it almost doesn't matter because they vote for people who do not think it is wrong.

One proof is the passage of Proposition 47, a California ballot initiative passed in 2014, under which theft of less than \$950 in goods is treated as a nonviolent mis-demeanor and rarely prosecuted. As a result, in Democrat-run California cities such as San Francisco and Los Angeles, retail theft has soared.

Walgreens stores are racking up the average of four times the amount of theft in Walgreens stores across the country; spending on security guards in San Francisco is 35 times more than the chain's average in other cities. Walgreens has been forced to close 22 stores in the city since 2016.

As reported in the San Francisco Chronicle: "The Safeway located in San Francisco's Castro neighborhood...was a longstanding, 24-hour fixture in the neighborhood. But as of last week, the store's hours have been cut back to 6 am to 9 pm. A Safeway person said that the cutbacks are "due to an increasing amount of theft at the store."

Further proof that the left doesn't think theft is wrong — at least when committed by a person of color — was an interview broadcast on NPR last year with the author of a book titled "In Defense of Looting." The NPR interviewer threw only softball questions at the author.

In the last election, Los Angeles voters elected San Francisco's previous district attorney, George Gascon, as their district attorney. It was Los Angeles' way of declaring stealing is not wrong.

And it is worth noting that it is not only racial minorities and the poor who make these elections possible, its also prosperous whites. The Los Angeles DA is a wealthy white, and he was supported by a white billionaire, George Soros.

It is hard to believe that millions of Americans do not deem stealing from stores morally wrong, so let's try to explain how this has come about.

Reason #1 is moral relativism. For as long as there has been a left, it has rejected moral absolutes. As a great British historian, Paul Johnson, pointed out a half-century ago in his magnum opus, "Modern Times," the secular world applied the relativism of the natural sciences to morality.

Reason #2 is the cause for reason #1: the collapse of the Judeo-Christian value system and the accompanying abandonment of, and often disdain for Biblical ethics. Biblical morality posits moral absolutes – meaning stealing is wrong for everyone, and certainly people of color. Yes, one can offer a biblical defense of a starving man stealing food for his starving family, but that is hardly what is happening in San Francisco and other American cities.

Reason #3 is Marxist morality. From Marx to the present, Marxism has divided the world not between right and wrong but between economic classes. Therefore, it is morally acceptable for members of the poorest classes to steal from members of the more affluent classes. This notion has made its way into young peoples' minds for decades.

About 30 years ago, I spoke to students from four Cleveland high schools. I asked them to raise their hand if they would steal something they really wanted from a department store if they were certain they would not be caught. Nearly all the students raised their hands. When I asked some of them to justify their reasoning, they all said the same thing: They wouldn't steal from a mom-and-pop store, but they would steal from "the rich".

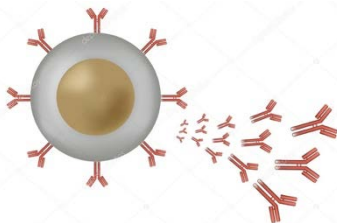
Reason #4 is the leftists' view that nonwhites, especially blacks, is a view conservative have never shared. Leftists truly believe that blacks are inferior to whites. The evidence? They do not believe blacks should be held to the same intellectual and moral standards to which leftists hold whites. Leftists do not defend whites who steal, and they hold whites to higher intellectual standards. Leftists do not argue for lowering math standards for whites, only for blacks.

Biden Cuts Off America's Monoclonal Antibodies Supply – Only "Vaccines" Allowed

The Biden regime is banning monoclonal antibodies by removing them from emergency use authorization (EUA).

The U.S. Food and Drug Administration (FDA) decided out of the blue to cut off America's supply of Regeneron, a "passive-vaccine" that many Democrats seem to oppose because it was promoted by President Donald Trump. (Related: Sen. Rand Paul called out Joe Biden for killing Americans by denying them access to monoclonal antibodies.)



In Florida, where monoclonal antibodies are widely popular, the state's department of health released a statement condemning the Biden regime's "abrupt" decision to eliminate access to monoclonal antibodies, which have been shown to prevent severe illness, hospitalization and death in high-risk patients who have contracted or been exposed to the Wuhan coronavirus (Covid-19).

As a result of the EUA's removal, all of Florida's monoclonal antibody administration sites are now "closed until further notice," the Florida Department of Health (FDH) tweeted.

"Unfortunately, as a result of this abrupt decision made by the federal government, all monoclonal antibody sites will be closed until further notice," the announcement reads.

"Individuals with appointments have been directly contacted regarding cancellations. If you have tested positive for COVID-19, please contact your health care provider for more information and resources on treatment options."

Monoclonal antibodies are safer and more effective than covid "vaccines"

The FDH clearly stated in the announcement that Florida "disagrees with the decision that blocks access to any available treatments in the absence of clinical evidence."

"To date, such clinical evidence has not been provided by the United States Food and Drug Administration (FDA)," the agency added.

The FDA decision applies to the entire country, just to be clear. It is now illegal, technically speaking, for providers to administer monoclonal antibodies in the U.S.

"The FDA is trying to make it so that people in Florida die of Covid," tweeted Mike Cernovich. "They'll kill people to harm Republicans. Steel yourselves for the evil that is being unleashed."

Gov. Ron DeSantis has been a heavy promoter of Regeneron, a drug said to help sick patients by giving them a quick fix of synthetic antibodies, which for many alleviates their symptoms quickly, often by the following day.

According to the FDA, monoclonal antibodies from both Regeneron and Eli Lilly should no longer be used because they are "unlikely" to be effective against the "omicron" (moronic) variant of the Fauci Flu.

Rather than allow patients and their doctors to make their own determination and decision, the FDA has decided to just go ahead and prohibit the drugs because they might not (but also might) work.

DeSantis, who helped set up infusion sites for Regeneron all across the Sunshine State, slammed the Biden regime over the FDA's decision. The governor has promised to fight for these treatments to return, "come hell or high water."

According to DeSantis, Biden swept in to cut off access to monoclonal antibodies right as it was becoming obvious that the treatment works better than the "vaccines" at helping sick patients recover.

"I believe that ivermectin, hydroxychloroquine, chlorine dioxide and many other remedies work to stop Covid-19 in its tracks," wrote a *Natural News* reader.

"I also believe that no one needs any more than a high-quality vitamin C combined with vitamin D3, and zinc to overcome even the most severe cases of Covid-19. I personally take 25,000 mg of vitamin C throughout the day when I am ill. I take up to 40,000 international units of vitamin D3 a day when ill, and up to 50 mg of zinc. This always

seems to do the trick. A shot of fresh squeezed lemon or a shot of apple cider vinegar with the mother to alkalize helps, too."

What Employees Of This Grocery Store Chain Confessed Is Bone Chilling
In Daily Headlines, 02-18-22

An alarming new survey of thousands of grocery workers across three western U.S. states reveals that they suffer from shockingly high rates of poverty. More than three-quarters of the workers meet the U.S. Department of Agriculture's definition of food insecurity," and 14% say they have been homeless within the past year.

The survey, which was funded by the United Food and Commercial Workers Union (UFCW) and conducted by the nonprofit research group the Economic Roundtable, drew responses from over 10,000 Kroger employees, the country's largest all-grocery chain. (Kroger also owns Fred Meyer, Harris Teeter, and City Market.) Do the workers surveyed live in Southern California, Washington state, or Colorado, and are they all UFCW members indicating that the abysmal conditions reported may actually be better than the average U.S. grocery worker, given that all of those surveyed have at least the minimal protections provided by union contracts.

Hungry at the Table: "White Paper on Grocery Workers at the Kroger Company" is the report's title.

Peter Dreier, a professor at Occidental College who co-authored the new report, believes that it is one of the largest independent surveys of retail workers ever performed in the United States. "We scoured pretty carefully the terrain of polling and surveys that have been done, and didn't see anything remotely close," he says.

Among the survey's findings:

Fourteen percent of Kroger workers are now homeless or have been within the past year. More than one-third say they fear being evicted. Even among full time employees, 15% say that they cannot pay their next rent or mortgage bill.

The study's authors calculated that a living wage for Kroger workers would be \$22 an hour, working full time about \$46,000 per year. But only 35% of the workers surveyed work full time, and the average wage for a Kroger worker is less than \$18 per hour, which amounts to less than \$30,000 per year. Even workers who have been at Kroger more than 14 years do not make a living wage, averaging under \$21 per hour.

Contrary to public perception, the majority of Kroger workers have some college or post-graduate education. Eighty five percent are high school graduates. Almost three-quarters of those surveyed say they are not fairly compensated for their experience and work, and more than 90% say they will not have enough money for retirement.

Despite working around food all day, one-quarter of Kroger workers say that they went hungry in the past year because they could not afford food. Fourteen percent say they receive food stamps. Kroger offers employees only a 10% discount on food at the store.

A quarter of workers say that their work schedule is so unstable that they do not know it more than one day in advance. Unstable work schedules are correlated with other problems, like food and housing insecurity.

A majority of Kroger workers say they were faced with customers who refused to wear masks during the pandemic. Only 43% of those who faced “disrespectful or threatening” customers say that management intervened to help them in those situations.

Though the survey only covers Kroger employees, it is fair to assume that the problems it describes apply to grocery workers across the U.S. Indeed, the descriptions of poverty and lack of workplace safety and support match what workers at other grocery stores have said repeatedly since the pandemic began.

The Big Lie Is ‘There Is No Election Fraud’

Yesterday, 204 legislators from various states called for a 50-state election audit, decertification of results where indicated, and possible convening of the U.S. House of Representatives to reconsider the 2020 election. Even if you believe anyone still questioning the outcome of the 2020 presidential race is telling a Big Lie or tilting at windmills, there are plenty of reasons to conclude we have a long way to go before most Americans will agree our elections are free, fair, and honest.

Georgia authorities opened an investigation into illegal ballot harvesting in the 2020 and subsequent Senate run-off elections. This followed reports there are videos of hundreds of ballot harvesters dropping tens of thousands of ballots into drop boxes in the middle of the night all across the state. A ballot harvester admitted being paid \$45,000 to illegally stuff drop boxes with ballots under cover of darkness. Former Georgia Senator David Perdue sued Fulton County officials for scanning absentee ballots multiple times and other voting irregularities affecting the outcome of the 2020 election.

In Michigan, a watchdog group found thousands of unverified ballots were counted in Detroit and, further, election officials there intimidated and blocked Republican election observers from doing their jobs.

In Pennsylvania, whistleblower video showed government officials throwing ballots into a trash can, disposing of machine tapes, and discussing getting rid of electronic election equipment even though they knew it would be a felony. The information came in the context of a lawsuit that alleges thousands of ballots were shredded and the data accompanying the act was deliberately erased before it had to be released under a document request.

In Wisconsin, an investigation found the number of illegal votes cast in the 2020 election was greater than Joe Biden’s margin of victory. Lack of voter ID was among the problems cited. A state lawmaker presented the findings of another team that uncovered 1.5 million illegal voter registrations, 155,000 suspected fake voters, and 50,000 illegally cast ballots.

In Arizona, Verity Vote found there was no documented chain of custody for 740,000 ballots cast in Maricopa County. Also, files were deleted from the election server before being handed over to the state senate under a subpoena. People were caught in the act on video. In Pima County, a witness testified here were 6 times as many military ballots than usual. They lacked chain of custody and went 95 percent for one candidate. Similar testimony was given in Michigan and Georgia where suspicious military ballots all or nearly all went for

Biden, suggesting organized fraud involving multiple states.

In Texas, the Secretary of State’s Phase One investigation found 700,000 invalid voter registrations were in place during the 2020 election, providing the vector for fraud to take place. The number included nearly 12,000 noncitizens, almost 450,000 dead voters still on the rolls, and over 200,000 duplicate registrations.

As if all this were not enough, federal government data show 15 million mail ballots disappeared in the 2020 election. Who knows where they went, but surely many were sent to vacant lots or the wrong address. So here we have the deadly combination of mass mail balloting with voter rolls that haven’t been cleaned in years. What could go wrong?

These are only the most recent revelations. Half the country believes the 2020 election was stolen. Now you know some of the reasons why. And it doesn’t inspire confidence when you hear things like the Wisconsin Election Commission recently enacting a rule allowing local officials to write-in required missing information on ballot envelopes, which surely must be contrary to state law or should be.

If you don’t want half the country believing future elections are stolen, you’re going to have to do better than all of this mess, way better. So, stop yapping about the Big Lie and voter suppression and start worrying about the basics of free and fair elections so the rest of us don’t have to worry about you and whether you have evil intent.

OUR FRAGILE UNION
