Immunization Updates

National Immunization Awareness Month

[National Immunization Awareness Month \(NIAM\)](#) is an annual observance held in August to highlight the importance of vaccination for people of all ages. Together, we can help raise awareness about the importance of vaccination and encourage people to talk to a healthcare provider they trust about staying up to date on their vaccinations.

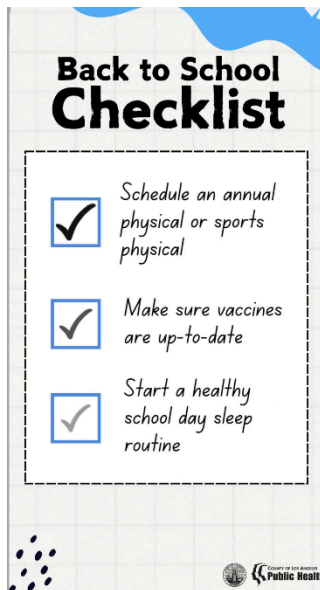

Children's Eye Health and Safety Month

[August is Children's Eye Health and Safety Month](#). It aims to raise awareness about the importance of eye care for kids. This month focuses on educating parents and caregivers about the need for regular eye exams, early detection of vision problems, and the prevention of eye injuries. Ensuring proper eye health and safety helps children perform better in school and enjoy a better quality of life.

Respiratory Disease Prevention Updates

COVID-19:

CDC recommends everyone ages 6 months and older receive an updated 2024-2025 COVID-19 vaccine when these vaccines are available later this year.

- [In the 2023-2024 season, hospitalizations were highest in individuals >75 years of age, followed by infants <6 months of age. Although there are no vaccines available for newborns, maternal immunization can help protect young children.](#)
- 50% of pediatric patients who were hospitalized had no underlying conditions. In older kids, asthma was the most common underlying condition.
- Only 5% of pediatric patients who were hospitalized had received 2023-2024 vaccine prior to admission.
- [More children were hospitalized or died from COVID-19 than Influenza last year.](#)

RSV:

Infants:

- [Two reviewed studies showed that nirsevimab was 77% effective against RSV-associated ED visits and 91-98% effective against RSV-associated hospitalizations. We estimate that roughly 21% of infants in Los Angeles County were protected from RSV from either receiving nirsevimab or through maternal vaccination.](#)
- This RSV season, we encourage all [birthing hospitals](#) and pediatric practices to administer nirsevimab to all eligible infants shortly after birth. To prevent severe RSV disease in infants, CDC recommends either maternal RSV vaccination or infant immunization with RSV monoclonal antibodies. Most infants will not need both.
 - **Immunization for infants and young children**
 - 1 dose of the monoclonal antibody product, nirsevimab, for all infants aged 8 months and younger born during or entering their first RSV season.
 - 1 dose of nirsevimab for infants and children aged 8–19 months who are at increased risk for severe RSV disease and entering their second RSV season.
 - **Vaccination for pregnant people**
 - 1 dose of maternal RSV vaccine (Abrysvo) during weeks 32 through 36 of pregnancy, administered September through January. Abrysvo is the only RSV vaccine recommended during pregnancy. Additional doses of RSV vaccine during future pregnancies are not recommended. However, these infants can receive nirsevimab.
