

Advocacy Week 2021 at Children's Hospital Los Angeles (CHLA)

The COVID-19 pandemic has resulted in over a year of virtual learning, as well as changes in how we view education. In response, the second-year pediatric residency class at the Children's Hospital Los Angeles (CHLA) selected a longitudinal advocacy focus on educational disparities in public schools.

More than 6.5 million school age children miss more than 15 school days per year. California data show one in ten students were chronically absent in 2019.^{1,2} There is extensive literature linking chronic absenteeism and childhood health outcomes, as well as links between educational attainment and adult health outcomes.^{1,3-7} Accordingly, pediatric providers have the opportunity to play a critical role.

The class advocacy group, led by residents Dr. Victoria Goldman and Dr. Bethany Burdick, hosted an Advocacy Week in August 2021 to raise awareness and provide education and tools to address these issues. This event consisted of speaker events, social media advocacy, as well as new handouts and screenings regarding school absenteeism for patients and families.

We hosted Grand Rounds with three expert panelists on educational disparities and chronic absenteeism, including: Ty Anthony Davis, Maryjane Puffer, and Dr. Rebecca Dudovitz. Additionally, residents Dr. Gabriella Rader and Dr. Katherine Rand spearheaded a social media takeover of AAP District IX Chapter 2's Instagram account (@AAPCA2), where we featured four important legislative bills from the California State Assembly (AB 22, AB 309, AB 563, AB 1117), as well as further information regarding chronic absenteeism.

In our outpatient clinics, resident physician Dr. Gabriella Puente created English and Spanish parent handouts on the health impacts of chronic absenteeism, and Dr. Goldman created and implemented new screening for school absences. In addition, we provided morning advocacy updates to our residency, and Dr. Jelena Ivanis orchestrated resident-led education on the link between health and school in our clinics. Dr. Goldman and Dr. Burdick look forward to exploring opportunities to work toward addressing educational disparities through increased communication and relationships between CHLA, our local community, and schools.
