On behalf of yourself and your children, you hereby release, covenant not to sue, discharge and hold harmless Second Presbyterian Church, its employees, agents and representatives, of and from all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating to participation in our programs, services or activities. You understand and agree that this release includes any claims based on the actions, omissions or negligence of this organization, its employees, agents and representatives, whether a COVID-19 infection occurs before, during, or after participation in any such program, service or activity.

As partners in protecting the health, safety, and well-being for each other, we agree to NOT send our youth to youth events if:

- they have been sick with a fever of over 100.4 in the last 24 hours
- they have any new symptoms of COVID (sore throat, chills, coughing)
- they have been in close physical contact (6 feet or closer for at least 15 minutes) with someone who is known to have COVID

If anyone in the household tests positive for COVID 19 or my child is quarantined, I will notify the Director of Children's and Youth Ministry and will NOT send my child to youth events until they have been released from quarantine by the health department.
