Claims Services

NPIP claims are handled by NPIP's administrator, Clear Risk Solutions, with experience in both property and liability coverage. The claims process is designed to be user-friendly and allows members to have a voice in how their claims are handled. In the event of a claim, the organization will contact the broker or Clear Risk Solutions. From there the claims team will begin an investigation and liability determination and the member will be contacted with a plan of action.
