## COMMUNITY ACTION OF NAPA VALLEY

**Community Action of Napa Valley Food Bank and Meals On Wheels** serves all of Napa County from American Canyon, Angwin, Pope Valley, Lake Berryessa., Calistoga, St. Helena, Yountville, and Napa. We serve any one that is in need of food or a Senior in need of meals. Monetary donations help us leverage our purchasing power. For every one dollar we can turn into five dollars.

**Meals On Wheels:** Serves meals 7 days a week, total 3,745 meals. Prior to the crisis we served 2,200 meals a week, an increase of 1,545 meals per week. The net cost is \$11,609 which is an extra cost of \$4,789 per week.

**Food Bank:** Supplies groceries and produce to 1,829 households. Over 132,140 pounds of food is distributed in one week. Four dairy items alone which cost \$1,400.00 per week now cost \$8,999.00.
