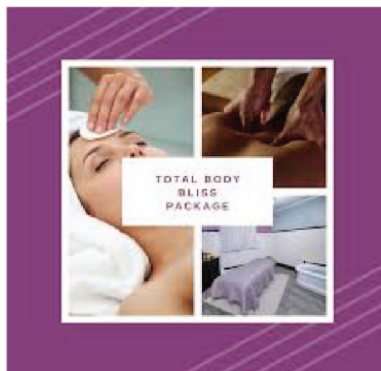
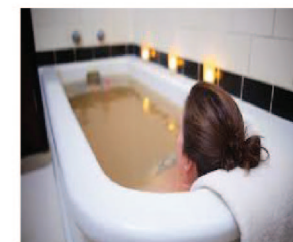
PAM'S DAY AT THE SPA
