AB 710 passed the Health Committee on Tuesday 11-4, but one thing was sure - the author of AB 710 and the Health Committee wasn't ready for our presence. They looked around at a room full of pink and thought we were there for them, camouflaged in a color they apparently own. Little did they know we were there to fight for Life and the Gospel.

3 MINUTES TO SPEAK TRUTH

Heidi had three minutes to state the case of pregnancy centers. Our Abortion Pill Reversal Patient had three minutes to share her experience. Six minutes total to explain to the committee what pregnancy centers actually do and why AB 710 is a gross misrepresentation of who we are.

And to say they didn't like what was being said is an understatement.

Heidi quickly shared the personal testimony of five patients. Each patient stood to testify to the work of Alternatives Pregnancy Center, and with each story, you could feel the hatred darken like a cloud. They needed more time to be ready for the display of strength, boldness, courage, and evidence presented to them. Immediately they reverted to defaming us with logical fallacies and arguments that their worldview had twisted into legitimacy. In short, they shamed us for protecting innocent life through Abortion Pill Reversal services. At that point, our voice was silenced.

What did we do then? We sat there and took the blows because our six minutes were up.

However, we didn't go to play politics - we went to defend pregnancy centers, Life, and the Gospel. And we did just that.

Abortion Pill Reversal treatment is a treatment that has saved nearly 80 lives at our clinic alone over the past several years, giving women a second chance at choice. Dr. Akilah Weber wondered what studies we could cite, knowing that the pro-abortion medical world has blocked every attempt at clarity or studied consensus on the topic. **At that moment, she proclaimed in front of the assembly that we spread false information even though ACOG themselves are conflicted in their findings, speaking out of both sides of their mouth.** Their own documentation claims that "there is no evidence that treatment with progesterone (APR) after taking mifepristone [abortion pill] increases the likelihood of the pregnancy continuing." However, they go on to say that, "progesterone-based drugs should not be taken during a medical abortion because they may increase the chances of fetal survival by 4 times (.9% vs. 3.6%) even after the

woman has taken the second drug." Really? Fascinating statistics Dr. Weber forgot to mention. The author of the bill then belligerently went on to shame us for the questions on our website regarding abortion, but what I wasn't able to say is that those questions come straight from their cited abortion sources on "How to help counsel a woman before an abortion offering her best practices."

Even though the Health Committee didn't recognize that AB 710 seeks to discredit the very facilities that women deserve access to in order to receive comprehensive medical care, we know that our God can do anything to protect his people. Thank you for upholding us in prayer, and please continue to pray that God's will will be done with this bill!
