How Do I Get Started?

After completing a one-time [registration](#) to obtain a username and password, log in to submit your position letter as a registered lobbyist, organization or individual seeking to communicate your views to the bill author's staff as well as the committee that will be hearing the bill.

How to submit a letter to the portal:

- 1) google ca legislation portal**
- 2) touch the blue registration word**
- 3) go through the program**
- 4) to select file. I used the PAGES app to write my letter of opposition. Then I : Export PDF, Save to files, Pages, and then Save.**
- 5) in the portal when I select file from PAGES app it's highlighted because I saved it in an export file.**

Here is a summary of some of the bad bills. I hope that you will address the committee that they are currently in. You can find out where the bill is, by going to CA legislation and searching for the bill by number and then looking at the bill history. Here is the link:

CALIFORNIA IS GOING TOO FAR.

Legislators have submitted **10 bad bills**.

Each of the bills build on each other to create a state where you will not be able to learn, work, play, or live without showing **proof of vaccination**.

SB 871 Requires all children 0 to 17 to get the COVID-19 vaccine to attend any daycare or public/private school; with no exemptions.	SB 866 Lowers the age of consent to age 12 to get the COVID-19 vaccine without parental consent.	SB 920 Authorizes the medical board to inspect a doctor's office and records without patient's consent. Violating HIPPA laws.	SB 1464 Forces law enforcement officials to enforce public health orders; even if they oppose, or adopts a policy to oppose, a public health order.	SB 1479 Requires schools to continue COVID testing and to create testing plans long term.
SB 1390 Censors any social media platform that posts dissenting information that contradicts the Government narrative; information regarding medicine or vaccinations, information regarding elections, and conspiracy theories.	SB 1184 Changes the California Medical Privacy act to authorize a health care provider or service plan to disclose your child's medical information to a school-linked services coordinator, without parental consent.	AB 1797 Makes changes to the California Immunization Record Database for government agencies to have access to all vaccine records in addition to just students.	AB 1993 Requires all employees, including independent contractors, to show proof of COVID-19 vaccination to work in California.	AB 2098 Classifies the sharing of COVID-19 medical opinion by doctors & surgeons contrary CDC narrative as "misinformation" and as unprofessional conduct that would result in disciplinary action.
