

CONTINUING SMALL BUSINESS RECOVERY AND PAYCHECK PROTECTION PROGRAM ACT

CONTINUING SMALL BUSINESS RECOVERY AND PAYCHECK PROTECTION PROGRAM ACT

- Authorizes \$100 billion in long-term, low-cost loans to recovery sector businesses, which include seasonal businesses and businesses located in low-income census tracts that meet the applicable SBA revenue size standard, have no more than 500 employees, and demonstrate at least a 50 percent reduction in gross revenues.
- Loan amounts would be available at up to twice the borrower's annual revenues, not to exceed \$10 million. The loan would have a 100% SBA guarantee and maturity of up to 20 years with a one percent fixed interest rate to the borrower.
- **Two-year deferred**; Administrator would be given the authority to grant an additional **two years** deferment
- Waives the SBA's credit elsewhere test and allows the borrower to defer loan and interest payments for the first 2 years.
- Allowable loan uses include **working capital, acquisition of fixed assets, and refinancing existing indebtedness**.

CONTINUING SMALL BUSINESS RECOVERY AND PAYCHECK PROTECTION PROGRAM ACT

PPP Second Draw Loans:

- Provides \$190 billion of committed and appropriated funds to support PPP and PPP Second Draw Loans.
- Defines eligibility for **PPP Second Draw** loans as small businesses that meet the applicable SBA revenue size standard, have no more than **300 employees**, and demonstrate at least a **50 percent reduction in gross revenues**.
- Includes a \$25 billion set-aside for entities with 10 or fewer employees and a \$10 billion set-aside for loans made by community lenders.
- The **maximum loan size would equal 2.5 times average total monthly payroll costs**, up to \$2 million. Businesses that received a PPP loan may not receive another PPP loan that aggregates to more than \$10 million.
- The **60/40 cost** allocation for payroll and non-payroll costs to receive full PPP forgiveness continues to apply.

CONTINUING SMALL BUSINESS RECOVERY AND PAYCHECK PROTECTION PROGRAM ACT

PPP Improvements:

- Expands forgivable expenses to include **covered supplier costs, covered worker protection expenditures, and covered operations expenditures.**
- Allows borrowers to select a **preferred 8-week period through 2020** to use the forgivable loan proceeds.
- Simplifies the forgiveness application process for smaller loans.

\$150 Billion

Funding to cover the next 6 months of payroll, benefits, and fixed operating expenses for businesses that have taken a substantial revenue hit during the COVID-19 pandemic.

A share of that loan will be forgiven based on the revenue losses suffered by the business in 2020, and the remainder can be repaid over 7 years, with no interest payments due in the first year and no principal due for the first two years.

This program is designed to provide small- and medium-sized businesses with loans to get their businesses going again and ensure that they receive loan forgiveness to help fill in a loss in revenues.

S. 3814 RESTART ACT

Loan Terms/Amount/Eligibility:

- 7-year loan, capped at 45% of 2019 gross receipts up to \$12 million
- 100% federal guarantee for life of the loan
- Employment cap of 5,000, with streamlined procedures for less than 500 employee firms
- No cap on loan size based on multiple of payrolls
- Self-certify a revenue loss of 25%
- Interest Rates/Payment Schedule:
 - No principal payments required for the first 2 years
 - Fixed interest rate between 2% and 4% for the first 2 years
 - § No interest payments due for first 12 months
 - § Payments of interest only for next 12 months
 - Interest rate for years 3 to 7 is the Applicable Federal Rate (AFR) plus a spread of 250 - 450 bps, based on revenue decline
- Restrictions on dividends/share buybacks/executive compensation for duration of loan with special rules for pass-through entities

S. 3814 RESTART ACT

Use of Funds:

- Businesses can borrow to pay for an array of business costs including the following:
 - Total payroll (up to \$100k per employee)
 - Employee benefits (for both current and furloughed employees)
 - Rent
 - Utilities
 - Mortgage interest payments on existing mortgages
 - Other scheduled debt service
 - Personal Protective Equipment

S. 3814 RESTART ACT

Loan Forgiveness:

- Level of forgiveness based on decline in revenues and may be received within 2 years of the loan origination
- No requirement to increase staffing beyond what business conditions dictate
- Smaller business forgiveness (<500 employees) more generous than for larger businesses
 - Small Business Forgiveness based on a formula including percentage decline in revenues for Payroll + Benefits + Operating Costs
- Larger businesses follow same forgiveness, except for payroll (i.e. benefits and operating costs fully included but not payroll)

Paycheck Protection Program

Forgiveness

- <\$150,000 forgiven
- < \$1 million intermediate forgiveness



Small Business Tax Provisions

- Enhanced employee retention tax credit
- Tax deductions for employer purchases of PPE (testing equipment, and other supplies).
- Business meal deduction would also increase from 50% to 100%.

Coronavirus Liability Protections

- Provide a shield for **businesses**, non-profits, schools, medical providers, and medical professions.
 - Gross negligence or intentional misconduct
 - Federal court
 - Sunset at the end of a federal COVID-19 emergency declaration or 2024, whichever comes later.

\$10 billion assistance for providers of transportation services affected by COVID-19.

- **PROVIDER OF TRANSPORTATION SERVICES.**—The term “provider of transportation services” means an entity that—
 - Established or organized in the United States; or pursuant to Federal law; has significant operations, and a majority of employees based, in the United States; was in operation on March 1, 2020; and is the operator of—
 - Vessel of the United States (as defined in section 116 of title 46, United States Code) that is—
 - Passenger vessel (as defined in section 2101 of title 46, United States Code) carrying fewer than 2,400 passengers; or small passenger vessel.
 - company providing transportation services using a bus characterized by an elevated passenger deck located over a baggage compartment (commonly known as an “over-the-road bus”), including **local and intercity fixed-route service, commuter service, and charter or tour service (including tour or excursion service that includes features in addition to bus transportation, such as meals, lodging, admission to points of interest or special attractions, or the services of a guide).**
 - Company providing transportation services using a **school bus**.
 - Any other transportation service company subject to regulation by the Department of Transportation as the Secretary, in consultation with the Secretary of Transportation, determines to be appropriate.

S. 4150 CERTS ACT

C O R O N A V I R U S E C O N O M I C R E L I E F F O R T R A N S P O R T A T I O N S E R V I C E S A C T

ELIGIBLE PROVIDERS OF TRANSPORTATION SERVICES

- Provider of transportation services on March 1, 2020
- 500 or fewer employees and was not a subsidiary of, or controlled by, another entity with a combined total full-time workforce of more than 500 employees; or
- Provider of transportation services on March 1, 2020
- More than 500 employees and has not received assistance under paragraph (1), (2), or (3) of section 4003(b), or subtitle B of title IV, of the Coronavirus Aid, Relief, and Economic Security Act ([Public Law 116-136](#); 134 Stat. 281).

S. 4150 CERTS ACT

C O R O N A V I R U S E C O N O M I C R E L I E F F O R T R A N S P O R T A T I O N S E R V I C E S A C T

AMOUNT

- The Secretary shall take into consideration–
 - estimated revenue and cash flow of the provider of transportation services during the 12-month period beginning on the date of receipt of the assistance;
 - amount of debt owed by the provider of transportation services on major equipment
 - other sources of Federal assistance provided to the provider of transportation services.
- (B) LIMITATION.–The Secretary shall ensure that the amount of assistance provided to a provider of transportation services under this subsection, when combined with any other Federal assistance provided in response to COVID-19 under the Coronavirus Aid, Relief, and Economic Security Act ([Public Law 116-136](#); 134 Stat. 281), the Paycheck Protection Program and Health Care Enhancement Act ([Public Law 116-139](#); 134 Stat. 620), or any other provision of law, **does not exceed the total amount of revenue earned by the provider of transportation services during calendar year 2019.**
- **Secretary shall ensure that not less than 50 percent of the amounts made available are used to provide grants.**
- **Secretary shall ensure equal access to the assistance provided under this section to eligible providers of transportation services that are small, minority-owned, and women-owned businesses.**

S. 4150 CERTS ACT

C O R O N A V I R U S E C O N O M I C R E L I E F F O R T R A N S P O R T A T I O N S E R V I C E S A C T

CONDITION OF RECEIPT

- Require that a provider of transportation services shall agree—
 - use the funds, on a priority basis and to the extent available, to maintain through December 31, 2020, pay, paid administrative leave, and benefits to all employees as of the date of enactment of this Act, after making any adjustments required for—
 - Retirement, voluntary employee separation; and
 - **Recall or rehire any employee laid off, furloughed, or terminated because of reduced service as a result of COVID-19 or the effects of COVID-19, to the extent warranted by increased service levels.**
- Eligible activities.
 - Activities to ensure the preservation of jobs based in the United States;
 - Acquisition of services, equipment, including personal protective equipment, and other measures needed to protect workers and customers from COVID-19.
 - Continued operations and maintenance of existing capital equipment and facilities (including **rent, leases, insurance, and debt service**) during the period of economic distress caused by the outbreak of COVID-19.


