For the 2019 year, The National Youth Involvement Board (NYIB) is offering two (2) awards. The Outstanding Voting Delegate of the Year and the Outstanding Volunteer of the Year awards recognize outstanding individuals for their support and dedication to financial literacy and NYIB goals. These awards are designed to recognize individuals and are not scholarships. Both awards will remain confidential through the consideration process.

All nominations with supporting documentation must be received or postmarked **by June 7 2019**. Winners will be announced at the 2019 NYIB Conference during the NYIB Award Ceremony.

Eligibility Requirements:

- All award nominees should be involved with financial literacy within their credit union or League/Association.
- A nominee can only be awarded each of these awards once within their credit union movement tenure.
- All completed and signed nominations along with supporting documentation, must be received or postmarked on or before **June 7, 2019**.

Nomination Application Instructions:

- All parts of the application must be completed and signed. All information included in the application will be treated as confidential. Incomplete applications will be disqualified.
- All applications must be accompanied by two (2) supportive, typed, letters of endorsement. One (1) letter of endorsement must be from the applicant's Credit Union Manager/CEO or League President.
- A digital photo of the nominee must be submitted by the deadline of **June 7, 2019** as well. Please submit to polson@wingsfinancial.com.
