Guest Speakers:



Brent K. Sugimoto, M.D., MPH, FAAFP, is a family physician and HIV specialist. He has dedicated much of his career to improving outcomes in HIV care, prevention, and access. With a focus on care for adolescents and adults living with HIV at Kaiser Permanente in Oakland, CA, he worked to improve outcomes for this population, and began efforts to screen and intervene for Adverse Childhood Experiences, which are over-represented in persons living with HIV. He has lectured nationally on the need for ACE screening for men who have sex with men (MSM) at risk for HIV infection.

He is also an educator and author of ACEs education for primary care. Dr. Sugimoto has been a national leader in the American Academy of Family Physicians, the largest medical specialty association in the U.S., where he currently serves as the New Physician member on the Board of Directors. Past roles include serving on the Subcommittee on Health Equity. Currently he is Chief Medical Officer for Decoded Health, a technology startup using artificial intelligence (AI) to achieve the Quadruple Aim. He is also a member of the AI in Primary Care Executive Roundtable, a panel that advises the Alliance for eHealth Innovation. Dr. Sugimoto received his medical degree from the University of California (UC), San Francisco, his MS as part of the UC Berkeley-UC San Francisco Joint Medical Program, and his MPH from UC, Berkeley. Dr. Sugimoto lives with his husband and two children in Richmond, California.
