This course will offer an update on the latest research findings and clinical applications in the diagnosis and treatment of individuals with autism spectrum disorders. Attendees will learn of the growing body of knowledge in the delivery of treatment as well as review the scientific basis, early risk factors, and other issues associated with individuals with ASD. Learning formats, including group case discussions, Q and A, panel presentations, and didactic lectures will be used to assist in developing new strategies that participants can apply in their practice settings. The course is intended for mental health and health clinicians and others interested in the understanding and treatment of children/adolescents/adults/and their families with autism spectrum disorders. **Learning Objectives:** As a result of attending this course participants will be able to: identify neurological, psychopharmacological, and communication advances; explain early identification, sleep disturbances, social skills, anxiety, and what therapy works best for whom across the spectrum; define strategies to help older clients, parents, and couples; describe disparities in treatment; and review how an integrated care approach can enhance cooperation between provider and patient.
