**What You Will Need To File Form 2290:**

- ★ **Your business name** (if you don't have a business name you can use your personal name as a Sole Proprietor)
- ★ **Address** (a sole proprietor can use their legal home address)
- ★ **EIN** (Employer Identification Number) -
  - **\*Please Note: You must have your own EIN to file Form 2290.** The IRS stopped accepting social security numbers for Form 2290 in 2011. If you need an EIN number, please contact us at **877-520-8640** for assistance.
- ★ **Truck Information**
  - VIN number (Vehicle Identification Number)
  - Taxable Gross Weight of vehicle (This should be your registered GVW - 80,000 lbs.)
- ★ **Form of payment for the tax due to the IRS (\$550.00 when renewing)**
  - See **Step 4** below for accepted IRS payment methods.

**Steps To E-File at [trailertrans2290.com](https://trailertrans2290.com)**

**Step 1:** Go to [trailertrans2290.com](https://trailertrans2290.com) and click **START MY 2290 NOW**. Enter your contact details and then click **Create Account**. If you already have an ExpressTruckTax account, simply click **Sign In**.

**Step 2:** Add all required details about your business including Business Name, EIN, Address, etc. Then click **Save and Continue** at the bottom.

**Step 3:** Click **Start New Return**, then select **E-File for 1 or Multiple Vehicles** under the Form 2290 option.

- If filing for a single vehicle, choose the single truck filing option.
  - Then enter all required information on a single page.
- If filing for multiple vehicles, choose File for Multiple vehicles
  - Then select your Tax Year and First Used Month.
- If you are simply renewing for the 2022-23 tax year, you should select **July 2022** as your First Used Month.

**Step 4:** Choose your IRS tax payment method:

- Electronic Funds Withdrawal (EFW) for direct debit,
- Check or money order,
- EFTPS (Electronic Federal Tax Payment System) - this is only recommended if you already have an established account at EFTPS.gov,
- Credit or Debit Card payment can now be made for Form 2290 at [www.irs.gov/payments](https://www.irs.gov/payments)

The **Consent to Disclosure of Tax Information** and **3rd Party Designee** pages are **optional**. Run through the error check, pay the \$14.90 e-filing fee, and click **Transmit your return to the IRS**. After you e-file, your stamped Schedule 1 will be sent directly to your email address as well as to **Trailer Transit**.
