The Florida Department of State (DOS) submitted four-ranked lists to the Florida Legislature for its review and funding consideration of four-separate Division of Cultural Affairs (DCA) grant programs. A total of 638 qualified and recommended 2017-2018 DCA grant applicants, based in forty-two Florida counties, request a total of four separate state appropriations in Florida's FY 2018 budget that totals \$52,311,010. This state investment will return \$5 for every \$1 invested to Florida's local and state government treasuries and leverage over \$1 billion in required matching dollars from both private and other public sectors.
