## **Junior High Mock Trial Member Guidelines and Participation Agreement**

St. Junipero Serra Catholic School is proud to announce the continuation of the JSerra Junior High Mock Trial Tournament on campus. This group will be offered to students in grades seven and eight. The goals of this tournament are to introduce the students to many of the aspects and components of a criminal trial. Students will learn about the criminal trial process and the courtroom set up. They will also learn about the elements of a criminal trial and how to present those elements to a presiding judge during a court trial.

As far as personal goals, students will improve their analytical, thinking and reasoning skills, their oral advocacy skills, and develop a personal knowledge of key trial and legal concepts.

Lastly, students will gain experience in working as a team, and an appreciation of the importance of ethical, respectful and polite behavior expected in a courtroom setting. The St. Serra team(s) will meet multiple times leading up to the tournament which will be held in March. The facilitator, Mrs. Benudiz, will be present at all meetings.

### **Guidelines and Rules of Conduct**

- 1) Candidate Requirements and Selection Process:** The Junior High Mock Trial team is open to students in grades seven and eight who are interested and committed.
- 2) Attendance:** Students are expected to attend every meeting during the school year.

**4) JSerra Mock Trial Tournament:** JSerra will create seven courtrooms at their campus facility in San Juan Capistrano. Each participating junior high school team will be given the opportunity on **Thursday, March 7th, 2019**, to participate in four (4) mock trials at the JSerra campus. The trials will begin promptly at 8:00am. Teams are advised to arrive at the JSerra campus no later than 7:30am so they can check in teams. Each trial will last approximately 40 minutes. The trials will end at about 11:30am. There will be a luncheon provided by JSerra for all students, teachers, chaperones, coaches and parents. The luncheon will start around noon and end at 1:00pm.

*\*\*\*Students will be expected to wear their formal uniform to the tournament\*\*\**

**\*Parents will drive their own children to this event. Carpooling is encouraged! A St. Serra bus will be provided to bring students back to school.**

**5) Awards:** Trophies will be awarded to the top three (3) teams. At the end of the trials, each team coach will choose their own team MVP. This MVP will receive special awards acknowledging their outstanding performance.

**6) Junior High Mock Trial Participation Fee:** There is no fee for this program.

**7) Parent Support:** Volunteer opportunities include: coaches (parents with any legal background) and chaperones.
