The Health Career Access Program

The Health Career Access Program (HCAP) is a paid work and training initiative for individuals seeking an entry point to employment in health. New hires will start as a Health Care Support Worker providing non-direct care at a long-term care or assisted living site and receive paid training to become a Health Care Assistant upon successful completion of the program.

HCAP has many benefits for employers who will have the opportunity to access new provincially funded staffing and training resources and play a key role in building capacity in the BC health sector and economy.

Participating employers will be provided with funding to cover education and salary costs to hire Health Care Support Workers who will provide critical non-clinical support while enrolled in a new modular Health Care Assistant training program. The HCAP will roll out as a partnership between candidates and employers to work through onboarding, orientation, employer-based training, and the HCA employer-sponsored training program.

This Employer Expression of Interest is available to operators of long-term care and/or assisted living sites with both public and privately funded beds.

Employer Expression of Interest (EOI)

Submission of an EOI does not commit employers to participation in the Health Career Access Program. Rather, the form is a first step for employers who want to be considered or are interested in knowing more about the HCAP opportunity. After the form has been submitted, operators will be contacted with more information and next steps.

Operators must complete **one Expression of Interest form for each site** that may be interested in participating in the Health Career Access Program.

Submitted forms must be received by Tuesday, November 3, 2020.
