



## OFFICIAL RACING RULES OF THE RUBBER DUCK DASH

1. The Temple-Belton Board of REALTORS, Inc. is a non-profit organization as defined under Section 501(c)(6) of the Internal Revenue Code (the "Presenter"), is sponsoring the TBBOR Duck Dash ~ Rubber Duck Dash for the purpose of raising monies to benefit the Foster Love Bell County a charitable organization as defined under Section 501(c)(3) of the Internal Revenue Code.
2. The Presenter reserve the right to postpone or reschedule the Rubber Duck Dash in the event of inclement weather, acts of God or other circumstances beyond the Presenters' reasonable control. The Presenters will conduct the contest on the designated date and time for a chance to win prizes as advertised (max. value \$50,000.00) on the website at [TBBORDuckDash.com](http://TBBORDuckDash.com) or such list can be obtained by requesting the list.
3. The Rubber Duck Dash is a raffle under the Texas Charitable Raffle Enabling Act, effective January 1, 1990, using an alternative drawing format.
4. The Presenters reserve the right, as their sole option, to substitute prizes of comparable value.
5. The prize list is subject to change at the sole discretion of the Presenters.
6. No cash equivalent will be awarded in lieu of designated prizes. Any and all taxes and similar fees, including, but not limited to, applicable license and registration fees are the sole responsibility of the winner.
7. All ducks entered will be provided by the Presenters and shall remain the property of the Presenters.
8. Contest can be entered by completely filling out the entry portion of each entry ticket and having it delivered to the Presenters or an authorized representative or mailed to the Presenters and actually received by the Friday prior to the Race for the entry to be eligible for prizes. Entrants assume responsibility for non-deliverable entries.
9. Rubber ducks will be dropped into Nolan Creek in Yettie Polk Park from the Central Avenue Bridge. Should the Central Avenue Bridge be unavailable for the drop, an alternative location will be determined by the Presenter.
10. Once a duck is dropped, placed, or released into the race, the duck is on its own. Neither the public nor event staff may free a duck if it is trapped, stuck or obstructed from floating. Any duck touched or interfered with by the public will be ineligible from the prize pool.
11. Only 1 Grand Prize will be awarded to the first duck to float across the finish line.
12. Additional prizes will be awarded to the holder of the ticket number that corresponds to the number that is tagged on the other winning ducks. Prizes are non-transferable. All prizes must be claimed from the Presenters within thirty (30) days. Prizes will not be mailed or shipped but must be picked up by the winner.

13. Winners will be announced at the TBBOR Duck Dash Festival on the day of the event. A list of prizes and winners and the means for claiming prizes after the TBBOR Duck Dash Festival will be posted online at [TBBORDuckDash.com](http://TBBORDuckDash.com) or can be obtained from the Presenters by sending an e-mail request or in person at the Presenters location after the race has concluded.
14. The contest is open to all persons. In the event of a winner under the age of 18, the grand prize will be awarded to the legal parent or guardian.
15. Employees of the Presenters may not participate and are not eligible to win the grand prize.
16. Entrants do not need to be present to win a prize. Entrants who are not present, who win a prize, will be notified by email, U.S. Mail, telephone, in person, or by posting noted in paragraph 14 above.
17. All tickets purchased or ducks adopted constitute charitable donations to the Presenter and are non-refundable.
18. Difficulties with getting to locations to enter the contest are not the responsibility of the Presenter.
19. By purchasing a ticket to adopt a duck or by entering, entrant's fully and completely release the Presenter, the Benefactor, each individually and collectively and each of their members, agents, employees, directors, supporters, volunteers, and the various organizations involved in supporting or sponsoring the TBBOR Duck Dash Festival.
20. As a grand prize winner or prize winner, you acknowledge and agree that the Presenters have the right to, without further authorization, publicize your name, character likeness, photograph, voice, and the fact that you are a grand prize winner or prize winner for promotional purposes without financial remuneration.
21. Participation in the contest and prizes awarded are non-transferable. Failure to collect the prize constitutes forfeiture of the prize. If forfeited, the prize will remain the property of the Presenters. Another winner will not be selected.
22. The Presenters reserve the right to make or change rules or contest changes without notice at any time and reserve the right to change the aforementioned contest date without notice.
23. The decision of the Presenters' management in the interpretation of these rules is final. By participating, persons agree to be bound by all the decisions of the judges and the official contest rules.
24. If the winner is found in violation of these rules he/she may be required to forfeit his/her prize.
25. Odds of winning the grand prize and other prizes depend on the number of adoption entries.
26. This event is subject to all federal, state and local laws and regulation and is void where prohibited by law.
27. The TBBOR Duck Dash and its logo are the property of the presenters, and no other person or entity is authorized to copy or otherwise use it without the express written consent of the Presenter.
28. The Presenter reserve the right to limit the number of adoptions per individual.
