Leon Guerrero-Tenorio Administration Expands Childcare Programs

Thousands of Working Families Now Eligible for Expanded Block Grant Assistance

Hagåtña, Guam – Effective today, thousands of the island’s working families are now eligible for expanded childcare assistance. The initiative follows Governor Lou Leon Guerrero’s [Executive Order 2022-07](#), which launched *Prugrãman i Pinilan i Famagu'on Guåhan* (Watching Over the Children of Guam Program). In addition to the administration of \$81.5 million in federal dollars, *Prugrãman Pinilan* tasks the Guam Economic Development Authority (GEDA) with developing

the eligibility criteria for grant recipients under the program, including before and after school care programs, relative care programs, extracurricular child care providers, employer child care assistance programs, and community care programs. As announced today, the first phase expands income eligibility, enabling more families to avail of childcare. If eligibility requirements are met, *Prugrãman Pinilan* can cover up to 100% of monthly child care costs (at a Child Care & Development Fund Program certified center) for families with children ages 0-13 years old.

More families now eligible

By increasing the eligibility threshold, thousands more Guam families, including our middle-class, are now eligible for financial assistance to cover child care costs through *Prugrãman Pinilan*,” said Governor Leon Guerrero. “This expanded eligibility program is the first in a series of *Prugrãman Pinilan* child care programs developed by our administration to meet the needs of Guam’s working families, support local businesses, and strengthen our economy. These programs will help more parents rejoin and stay in the workforce. In turn, local

“Working closely with the Department of Public Health and Social Services (DPHSS) and other agencies and nonprofits focused on youth and families, we have identified ways to strengthen existing programs and create new and innovative ways to provide care while continuing to focus on the health, safety, and well-being of our people,” said Lt. Governor Josh Tenorio. “In the coming weeks, we will announce several more childcare programs to provide support through employers, non-profits, after-school care programs, community care, relative care, boot camps, and apprenticeship programs.”

The *Prugrãman Pinilan* application period opens today, April 5, 2022. Program and eligibility specialists will be accepting block grant applications via email at qcgrants@investguam.com.
