NOTICE REGARDING COVID-19

Island Equipment Company takes the health and safety of its customers, employees, and their families very seriously. The Novel Coronavirus (COVID-19) pandemic is a dynamic situation, but we want to reassure our customers that we are taking precautions to keep our employees and customers safe, while continuing to fulfill product requirements and provide the best possible service during this pandemic.

In accordance with Executive Order No. 2020-05, issued on March 19, 2020 as an essential supplier for healthcare operations and essential infrastructure, such as public utilities on island we will continue our operations in a limited capacity during the government mandated social isolation period*. */*Mandated Isolation Period extended for 30 days by Governor of Guam (EO 2020-09)*/*

Our Harmon location will be CLOSED throughout the government mandated isolation period from 12:00pm, March 20, 2020 thru May 5, 2020

Our Agat location will remain OPEN for production operations and limited retail sales. We have policies in-place to support good health for our employees and their interactions with each other and customers. The hours of operation for our Agat Retail Store will be Monday through Friday, 7:30am - 2:00pm

We will be prioritizing customers requiring medical-grade products, including but not limited to Medical Oxygen – at this time all other orders and requirements will NOT be fulfilled or *may* be fulfilled on a solely discretionary basis upon proof and justification of critical requirement during this government mandated isolation period. NO onsite and field service, including fire extinguisher inspections will be performed during the government mandated isolation period and will be rescheduled after we resume regular business operations and hours. Furthermore, other than delivery of critical products, such as but not limited to Medical Oxygen and other medical grade products to hospitals and major medical care facilities, essential products to public utilities and military, we will cease all delivery and pick up services during the government mandated isolation period.
