Caring for Our Community

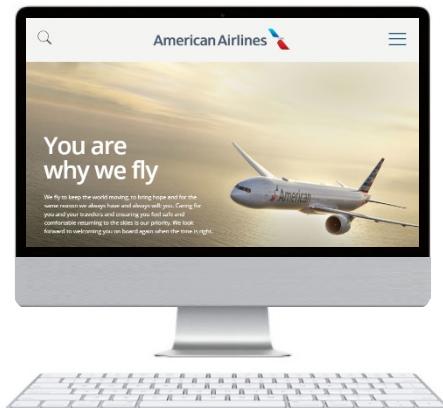

A Fond Farewell to Five Fantastic Fleets

American announced plans to accelerate the retirement of older, less fuel-efficient aircraft sooner than originally expected. American has officially retired the Embraer E190 and Boeing 767 fleets, which were originally scheduled to retire by the end of 2020. The airline has also accelerated the retirement of its Boeing 757s and Airbus A330-300s. Additionally, American is retiring 19 Bombardier CRJ200 aircraft operated by PSA Airlines.

- SKCHG/ASIASUSP – Asia Suspension
- SKCHG/SASUSP – Americas/Caribbean Suspension
- SKCHG/EUSUSP – Europe/Middle East Suspension
- SKCHG/SPSUSP – South Pacific Suspension

Waived Name Change Fees

Corporate accounts receive one free name change during the validity of tickets purchased on or before May 31, 2020.

Your agency of record can now process this complimentary name change in their GDS without requiring a waiver code. A contracted Corporate Travel Agreement must be active and the ticket must contain a valid Corporate CART or JBID in the endorsement box or tour code field.

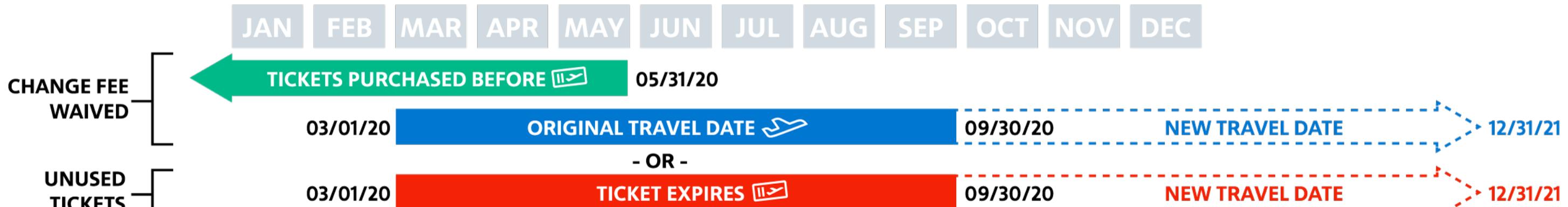
You can also continue to process name changes in SalesLink through May 31, 2020.

Flexible Fare Offering



This applies to published non-refundable fares

Global Flexibility Waiver applies to this Flexible Fare Offering for tickets purchased between March 1, 2020 to May 31, 2020

Conditions of Carriage

- For original tickets purchased on or after April 8, 2020
- Tickets will not be refund-eligible unless the flight time moves more than 4 hours (240+ minutes)
- If your confirmed flight cancels, you are still eligible for a refund as usual
