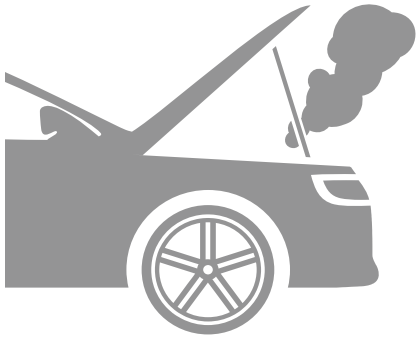

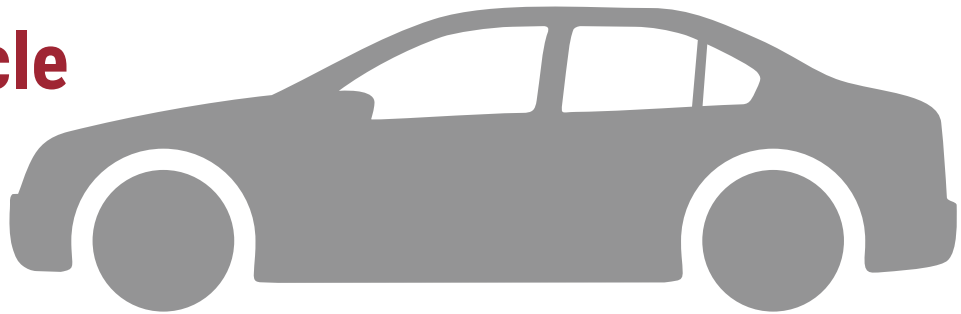
The automotive aftermarket industry in Canada is worth **\$21.6 billion**

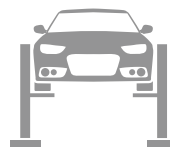

## OUR KEY ACTIVITIES



In 2017, AIA Canada testified before the Senate Committee on Transport and Communications as part of the committee's study on the deployment of connected and autonomous vehicles. Our testimony featured prominently in two final government reports.



AIA Canada currently sits on the multi-stakeholder Car of the Future Advisory Group co-led by Innovation, Science and Economic Development Canada (ISED) and Transport Canada (TC) whose goal is to position Canada as a global leader in advanced vehicle technology. We also participate in three of the group's expert-sub committees.



AIA Canada is taking the lead on bringing automakers and aftermarket signatories to the table to reexamine the Canadian Automotive Service Information Standard (CASIS) agreement to ensure all stakeholders benefit from advanced vehicle technology.
