

2020 AEDCE Scholarships Guidelines & Judging Criteria

Scholarship Guidelines

- Eligibility: Any current member of Arkansas Economic Developers & Chamber Executives (AEDCE) may apply for an AEDCE scholarship. Members may only apply for **one** training opportunity per person. More than one application may be submitted from each chamber/EDO but each individual staff member may only apply for one scholarship.
- Training Opportunities: Scholarship opportunities are available for the following training events:
 - o **US Chamber Institute (IOM)** Up to \$1,200 towards the cost of tuition
 - <u>Economic Development Institute (EDI)</u> Up to \$1,200 towards the cost of tuition for either inperson or online course attendance
 - o MAKO Conference (MAKO) Full conference registration cost of \$295
- Funds provided through the AEDCE scholarship program must be utilized in the fiscal year in which they are awarded (January 2020 December 2020). Funds may be applied retroactively if the training opportunity has already occurred before the scholarship awards are made (ex: Winter IOM).
- Scholarship funds will be reimbursed to the chamber/EDO after the registration/tuition costs have been paid by the chamber/EDO and appropriate documentation provided to AEDCE.
- Scholarship recipients must provide AEDCE with a copy of their transcript from IOM or EDI upon completion of the training opportunity.
- Should the scholarship recipient fail to attend their awarded opportunity, the chamber/EDO must reimburse AEDCE the amount of the scholarship provided.
- Scholarships are not transferrable unless specific authorization is provided by the AEDCE Board.
- Scholarship recipients will be asked to provide a written testimonial to AEDCE or volunteer at the AEDCE Annual Conference.

Criteria for Judging

- Scholarships will be judged by two panels. The first panel will be chamber/economic development
 professionals from a different state that will score the applications based on a rating scale that
 considers financial need, applicant responses, and written narrative.
- The second panel will be comprised of members of the AEDCE Board of Directors Scholarship
 Committee. They will review the first-round selections and take into consideration the applicant's
 commitment to the chamber/economic development profession in Arkansas before making any award
 decisions.
