GROUP REPORTS:

- **Laughlin Group of AA** (Bruce H.) Open discussion group which meetings Monday – Thursday at 2pm PST at the Riverside Resort Hotel and Casino on the 2nd floor. Average attendance 9-18 people. Business meeting is held the 2nd Monday of the month. Newcomers: 1-2; Visitors 3-4; Snowbirds 3-4. The group has a new treasurer and assistant treasurer.
