## 2016 SRT BATTLE OF THE SEXES TOURNAMENT RULES

1. THIS IS A SCRATCH TOURNAMENT OPEN TO ALL TNBA MEMBERS WITHIN THE SOUTHERN REGION OF THE NATIONAL BOWLING ASSOCIATION, INC.
2. THIS TOURNAMENT **MUST** START REGISTRATION AT 4:30 PM AND BOWLING WILL COMMENCE AT 5 PM. BOWLERS WILL NEED TO SHOW USBC AND TNBA CERTIFICATION CARDS. UNATTACHED TNBA MEMBERSHIP CARDS MAY BE PURCHASED ON-SITE AT A COST OF \$25 EACH.
3. TEAMS WILL CONSIST OF FOUR MALE AND FOUR FEMALE BOWLERS. THERE WILL BE A TEAM CAP OF 840. ALL PRIZE MONEY WILL BE RETURNED 100%. THE PAYOUT RATIO WILL BE ONE PLACE FOR EVERY FOUR ENTRANCES FOR EACH GENDER. NO PBA OR PWBA MEMBERS ARE ALLOWED TO PARTICIPATE.
4. ADVANCED ENTRIES AND/OR ANYONE PAYING BY CHECK MUST BE POSTMARKED BY THURSDAY, OCTOBER 20, 2016. ON-SITE ENTRIES WILL BE ACCEPTED CONTINGENT ON LANE AVAILABILITY AND WILL CLOSE 30 MINUTES PRIOR TO START TIME.
5. THE TOTAL ENTRY FEE OF \$120.00 MUST ACCOMPANY THE ENTRY FORM AND ALL CERTIFIED CHECKS AND MONEY ORDERS MUST BE MADE PAYABLE TO: TNBA SOUTHERN REGIONAL TOURNAMENT FUND. MAIL ENTRIES TO CHARLES H. WINTERS, P.O. BOX 263663, HOUSTON, TX 77207-3663. NO ENTRY FEES WILL BE REFUNDED AFTER THE CLOSING DATE NOR AFTER ON-SITE LANE ASSIGNMENTS HAVE BEEN MADE.
6. ENTRIES WILL BE TAKEN ON A FIRST COME, FIRST SERVED BASIS. THERE ARE ONLY 40 LANES AVAILABLE; THEREFORE, LANES ARE LIMITED TO THE FIRST 20 TEAMS FOR EACH GENDER.
7. THE TOURNAMENT COORDINATOR WILL PREPARE A PRIZE LIST AFTER THE ENTRIES ARE CLOSED AND THE SAME SHALL BE POSTED AT THE LANES WHERE THE TOURNAMENT IS BEING HELD.
8. ANY AND ALL SIDE ACTIVITIES (HANDICAPPED AND/OR SCRATCH) WILL BE CONDUCTED BY THE COORDINATOR AT THE TOURNAMENT SITE. PARTICIPATION IN ANY OTHER SIDE ACTIVITIES WHILE BOWLING IN THIS EVENT IS PROHIBITED TO THE EXTENT OF DISQUALIFICATION AND FORFEITURE OF THIS TOURNAMENT'S PRIZE WINNINGS.
9. TEAM CAPTAINS/SUBMITTERS, WHO WILL RECEIVE ALL CORRESPONDENCE, ARE RESPONSIBLE FOR THE ACCURACY OF ALL ENTRIES.
10. THE TOURNAMENT COORDINATOR RESERVES THE RIGHT TO DISQUALIFY ANY BOWLER NOT IN COMPLIANCE WITH THE RULES OF USBC, TNBA, AND THIS TOURNAMENT.
11. FORMAT: AT THE CONCLUSION OF REGISTRATION, ALL TEAMS WILL BOWL 3 SCRATCH GAMES. THE POSTED CASH PAYOUT WILL BE PAID. THEN, THE HIGHEST SCRATCH SCORE BOWLED BY EACH GENDER WILL BOWL A ONE GAME BAKER FORMAT TO DETERMINE THE WINNER OF THE BATTLE OF THE SEXES. EACH MEMBER OF EACH TEAM WILL BOWL 2 FRAMES WITH THE 9<sup>TH</sup> AND 10<sup>TH</sup> FRAMES BEING BOWLED BY THE LEAD-OFF AND ANCHOR BOWLERS RESPECTIVELY AS FOLLOWS. LEAD BOWLERS OF EACH TEAM WILL BOWL FRAMES 1 & 2, THE 2<sup>ND</sup> BOWLERS WILL BOWL FRAMES 3 & 4, THE 3<sup>RD</sup> BOWLERS WILL BOWL FRAMES 5 & 6, AND THE 4<sup>TH</sup> BOWLERS WILL BOWL FRAMES 7 & 8. UNLIKE THE NORMAL BAKER FORMAT, THESE BOWLERS WILL ALTERNATE ON EACH LANE BOWLED EXCEPT FRAMES 9 AND 10. THE LEAD BOWLER WILL BOWL THE 9<sup>TH</sup> FRAME ON HIS/HER STARTING LANE AND THE ANCHOR BOWLER WILL BOWL THE 10<sup>TH</sup> FRAME ON THE ALTERNATE LANE. FOR THE SUBSEQUENT GAMES, THE TEAMS WILL SWITCH STARTING LANES.
