Job Title: Physician Consultant (Internal Medicine or Family Medicine)

Location: Hybrid - Remote with occasional in-person meetings in Rhode Island

Time Commitment: 8 hours/month Position Type: Part-time Consultant

Position Summary

The Physician Consultant will support CTC-RI in advancing high-quality, advanced team-based primary care in Rhode Island through clinical consultation, content expertise, and collaborative planning. This position is designed for a practicing or recently practicing physician in Family Medicine or Internal Medicine who is interested in contributing to primary care transformation efforts on a contractual part-time basis annually.

The consultant will work under the direction of the Chief Clinical Officer and engage with CTC-RI projects, providing clinical insight and supporting planning and implementation of initiatives. No staff supervision or direct administrative responsibilities are required,

Key Responsibilities

- Provide clinical consultation and feedback on the design, implementation, and evaluation of primary care transformation initiatives.
- Participate in planning meetings, learning collaboratives, or stakeholder discussions, as requested by the Chief Clinical Officer.
- Review materials (e.g., protocols, screening workflows, clinical guidelines) and offer feedback based on primary care best practices.
- Provide subject matter expertise in adult medicine, with a focus on advanced team-based care, behavioral health integration, and management of chronic illness.
- Remain informed of current clinical practices and relevant guidelines related to substance use disorder treatment in primary care.
- Offer occasional ad hoc consultation on additional CTC-RI projects, as needed and within the 8hour/month scope.

Qualifications

- MD or DO with active licensure in Rhode Island (or eligibility to obtain)
- Board-certified in Family Medicine or Internal Medicine
- Minimum 5 years of experience working as part of an advanced team-based care adult primary care
 practice, preferably in a community-based or safety-net setting
- Experience integrating behavioral health or substance use care into primary care
- Experience with implementing quality improvement initiatives in primary care
- Strong written and verbal communication skills
- Ability to collaborate effectively with diverse stakeholders, including clinicians, care teams, and community organizations
- Knowledge of Rhode Island primary care landscape

Preferred:

- Familiarity with value-based care and alternative payment methodologies
- Experience with alcohol use screening and treatment in a primary care settings
- Comfort working in a hybrid environment and participating in virtual meetings
