No one goes through their career as a responder or medical professional unscathed. If you do the job long enough you will be affected. Responders and medical professionals are highly trained to do their jobs however, they are poorly equipped to handle and live with the traumatic situations they have encountered. In-fact, some of our training along with traits and behaviors learned to get the job done actually causes us to be susceptible to Posttraumatic Stress and Vicarious Trauma. Participants will learn how Posttraumatic Stress and Vicarious Trauma occurs, and how to identify when they or someone else has been affected. They will learn techniques to help become more resilient from being traumatized and techniques to help extinguish post incident reactions. Dr. Langus not only presents from a clinical standpoint on how to deal with trauma but, also through the eyes of a trauma survivor himself who lives with Posttraumatic Stress. Learn to handle traumatic incidences from a completely different view point without compromising tactical ability and training

Public expectations and scrutiny of law enforcement actions have never been higher. The primary focus of concern has become the interaction of officers with individuals in crisis. Dealing with individuals who are disabled as a result of mental health issues in dangerous situations often results in officers using force. Then the real test occurs. Officers must be able to withstand the test of their professional competence. The questions will come from training sources like POST LD20, SB 29, SB11 and subject matter experts who are preparing the questions. So - are you training your officers to explain how they have been trained?

Homelessness and criminalization of persons with severe mental illness, despite decades of discussion, attempted solutions and increases in resources devoted to solutions, has demonstrably gotten worse. The good news is that consistent public attention and public prioritization of these issues has increased compared to past decades in response to that attention. Law enforcement, mental health professionals, state and local agency leaders as well as policy makers are demanding solutions themselves and responding to demands from the public for solutions.

CIT programs are one evidence-based solution that can improve outcomes for those severe mentally ill persons on the streets. Saving lives, providing opportunities for treatment and recovery, and eventually reducing the ranks of the homeless and criminalized. This presentation will provide crucial information about opportunities provided in changes in state statute that command level officers, CIT trainers, and front-line CIT officers can use to further improve outcomes.
