2019 Leadership Award Nomination

The **Leadership Award** is generally awarded to a KSLA Senior Living Community Executive Director, Manager or Administrator. Any KSLA provider or associate member may nominate any KSLA Provider member for this award.

The award is based upon outstanding leadership demonstrated by a senior living industry professional in areas that may include the following:

- ◆ This candidate must demonstrate effective interpersonal skills that create space for the consideration of, and response to, the needs, feelings and capabilities of staff and residents, along with the ability to partner with and influence others to negotiate solutions to problems. This candidate must communicate effectively both orally and in writing with all levels of staff and residents.
- ◆ This candidate must be able to create cooperative working relationships with all members of the community by encouraging and facilitating cooperation within the team environment and throughout the community. This candidate must effectively demonstrate conflict management in a positive and constructive manner. He/she must create an environment of trust among the staff, residents and families of residents.
- ◆ This candidate must demonstrate a commitment to, and expectation of, continual learning among the entire staff. The leader must recognize his/her own strengths and weaknesses, as well as those of the staff, and pursue professional development and further education where needed.
- ◆ This candidate must encourage and enable others to provide quality resident service. He or she should possess and instill in others a spirit of service.
- ◆ This candidate must effectively manage finances, human resources, and technical resources effectively to get the most for the community. He/she must hold himself/herself and the staff accountable for accomplishment of responsibilities.
- ◆ This candidate should value cultural diversity and other individual differences in the workforce and apply policies, procedures, requirements, and regulations equally to all staff.

- ◆ The ability to measure and report the success or failure of a new process or program
