## I-105 EXPRESSLANES PROJECT

### VIRTUAL PUBLIC HEARING ADDED & COMMENT PERIOD EXTENDED

A live virtual public hearing will be held on **Wednesday, July 15, 2020, 6–7:30pm** to offer another option for comment submittal on the Draft Environmental Impact Report/Environmental Assessment (EIR/EA) and supporting documents for the I-105 ExpressLanes Project. See right column for complete details.

This is in addition to the live presentation and Q&A conducted on June 11. The video recording as well as the Draft EIR/EA and supporting documents are available on the project website and virtual open house (see right column). In-person public hearings will not be held to maintain social distancing requirements based on Governor Newsom's executive order, as well as recommendations from the California Department of Public Health to stay at home, limiting in-person gatherings.

Furthermore, the public comment period has been extended to **Monday, July 27, 2020**, to offer additional time for public review and comment on the Draft EIR/EA, Project Report, Concept of Operations (ConOps) and Traffic & Revenue (T&R) Study. The supporting Draft EIR/EA and Project Report technical studies, as well as printed copies of the aforementioned reports, are available upon request. ### PROJECT OVERVIEW

The I-105 corridor experiences heavy demand during peak commute hours that exceeds its capacity. As a result, Metro and Caltrans prepared an EIR/EA to study the possible implementation of ExpressLanes along I-105 between I-405 and Studebaker Rd in the City of Norwalk. The corridor traverses the cities of El Segundo, Inglewood, Hawthorne, Los Angeles, Lynwood, South Gate, Paramount, Downey, Norwalk and unincorporated areas of LA County.
