Dear 2022-2023 Scholarship Applicant:

We are pleased you are interested in our Eastern PA FBINAA scholarship program. It was established to provide financial assistance to the children/grandchildren of dues-paying members of the FBI National Academy Associates who are graduates of the National Academy. Also eligible are children of FBI National Academy graduates who were killed or died while employed in law enforcement.

The Committee has limited funds for scholarship grants, which are based on financial need, scholastic achievement, community-school involvement, leadership qualities and a demonstrated desire by the applicant for higher education. **There will be three scholarships awarded per year within Eastern PA Chapter boundaries.** The decision as to which applicants will be selected is determined exclusively from data submitted in the application. Therefore, it is very important to you that you carefully read the "Instructions" and "Requirements" which follow, and that your answers be complete, accurate and responsive.

These scholarships, which are for a one (1) year period of undergraduate study, will be for tuition only.

A separate application must be submitted for consideration each year you apply. The Scholarship Committee will have the sole responsibility for selecting the recipients for the scholarship awards.

INSTRUCTIONS:

- 1. Give detailed answers to all questions. If additional space is required, attach extra page(s)**
- 2. Type or print legibility application**
- 3. To be considered for a scholarship grant, this application and the necessary enclosures must be returned to the Scholarship Chair person by the deadline date of May 20, 2022. Failure to do so will result in rejection of your application**
- 4. Each application must be received from the responsible aged college applicant and not a family member**

REQUIREMENTS:

1. Attach a personally written statement, no longer than one (1) single spaced page, detailing why you need financial assistance, how the scholarship will help you in meeting your goals, and amplifying any data in the application. Please use Arial Font 12.
2. Attach a copy of your high school marks if you are applying for freshman year, or a copy of your college transcript if already enrolled in college. If you are unable to attach this information, have your school send it directly to us as soon as possible after your application is submitted, but no later than **May 20, 2022**.
3. Applicants **MUST** attach a copy of the father's/ mother's **active dues/membership card**. If National has not sent out the dues card, please show proof of paid membership for 2022 through FBINAA website.
4. Attendance at qualifying E PA Chapter meetings/events will be considered in this process.

If scholarship aid is granted, the funds are disbursed directly to your college bursar office. I look forward to receiving your completed application.
